


Background

To respond to the growing displacements the CCCM cluster was activated in May 2017. Under the co-leadership of UNHCR and IOM the cluster aims to improve the coordination of the integrated multi-sectorial response at site level, to raise the quality of interventions and monitoring of humanitarian services in communal settings, by ensuring appropriate linkages with and building the capacities of national authorities and other stakeholders.

National and Sub National coordination teams in place: National CCCM Cluster team in place with 2 co coordinators (IOM and UNHCR) plus IM officer. Sub national focal points in place in 8 districts with highest numbers of IDPs (Baidoa, Kismayo, Dollow, Galkayo, Garowe, Afgooye, Hargeisa and Bossaso)

Implementation of Detailed Site Assessment in 49 districts. The DSA - an inter-cluster and inter-agency initiative - aims provision of multi sector information on access, availability and gaps in basic service provision at the displacement sites. The DSA has been carried out by CCCM Cluster partner across the 49 districts and 19 regions since September 2017 to April 2018, reaching to over 1.75 million IDPs. The DSA contributed significantly to the formulation of the IDP number of 2.6 million people. To compliment the Detailed Site Assessment, the CCCM cluster has developed a new tool to improve site level data. The Comprehensive Site Assessment aims at collecting data at household level in IDP sites as well as mapping district level infrastructure in partnership with the Shelter Cluster. The assessment will focus on the 10 most affected districts.

13 integrated projects implemented. CCCM works closely with Shelter, Protection and WASH clusters to develop integrated packages for service provision in sites to ensure people have access to lifesaving services that meet minimum standards. To date, 13 integrated projects have been funded by SHF.

Improved site level coordination of humanitarian services in Baidoa. To date, there are 377 IDP sites in Baidoa that are benefitting from improved service delivery due to coordination and site management activities of CCCM partners. CCCM partners conduct quarterly site verifications, monitoring of service delivery, mappings of partners and community engagement activities to ensure participation and access to services of displaced populations. CCCM partners have also supported the government to ensure land tenure security for displaced people through the provision of government owned land for temporary accommodation of IDPs.

Site improvements in Dollow. In partnership with local authorities, CCCM expanded 2 IDP sites in Dollow, hosting more than 75,000 people. In order to ensure better access to services and more dignified living conditions, camp management replanned the sites and conducted internal relocations of more than 10,000 people. The new site plan meant that families had more household living space, better access to water and sanitation facilities and reduced risk of flooding and fires. In addition to physical site improvements, camp management has conducted house to house counts, vulnerability assessments implemented an address system which translates into better targeting of beneficiaries and ensures that services meet minimum standards.

Eviction risks mapping. In partnership with HLP sub cluster, CCCM partners are conducting eviction risk mapping of sites in 3 districts. CCCM partners work with protection partners and local authorities to mitigate evictions and identify new locations for IDPs that need to relocate.

GBV mitigation measures. In partnership with the GBV subcluster, CCCM partners are conducting safety audits in IDP sites in order to identify safety concerns associated with service provision in the displacement sites and advocate for site improvements to mitigate GBV.

Capacity building of stakeholders. CCCM partners have trained over 500 partners, local authorities, and community leaders in CCCM principles including roles and responsibilities of CCCM, community participation and care and maintenance.
