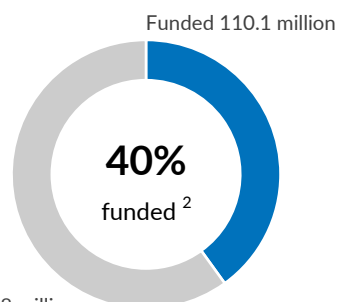

Notes:

- The financial requirements for Jordan include requirements for the Iraq Situation Response and the Syria Situation Response.
- The percentage funded is calculated using earmarked contributions pending the eventual allocation of broadly earmarked and unearmarked contributions.
- Contributions are shown by the level of flexibility in the earmarking. Contributions earmarked to a situation within a country are classified as country level.
- The broadly earmarked contributions listed are those which can potentially be used for Jordan due to their earmarking to a related situation or theme, or to the region or sub-region. The total amount of the contributions is shown for donors who have contributed \$2 million and more.
- The total amount of unearmarked contributions is shown for donors who have contributed \$10 million and more.
