The present partners identified some priorities; provision of water drainage system in camps and ITS affected by winterization.</p> <p><b>JRP 2019:</b> Two weeks ago, MoPIC has conducted a kick off meeting for the JRP 2019, which is transitional and lighter than last year, It will be only for 2019 (one-year-cycle), where sectors are requested to review their JRP 2018-2020 projects. MoWI has invited the WASH Sector partners to meet on 23 Oct to discuss the JRP 2019 perpetration.
