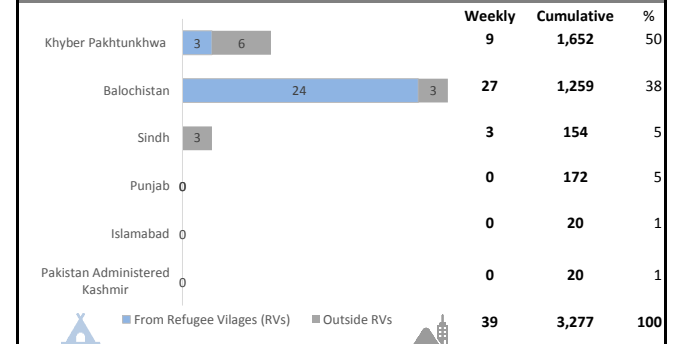

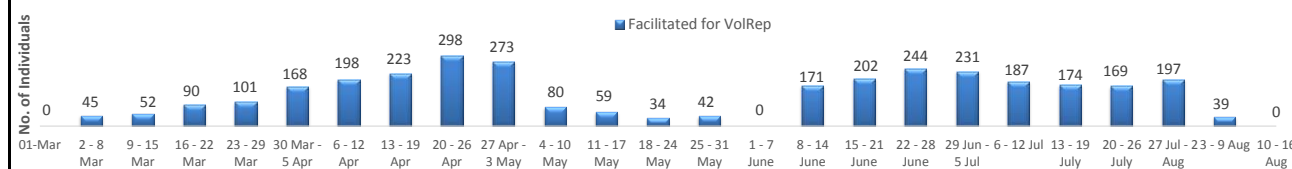

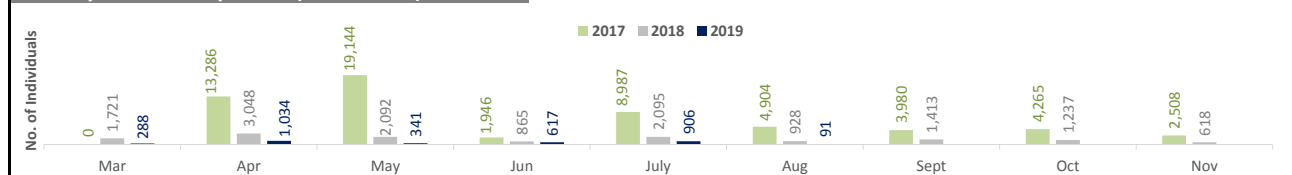
Province Residence in Pakistan



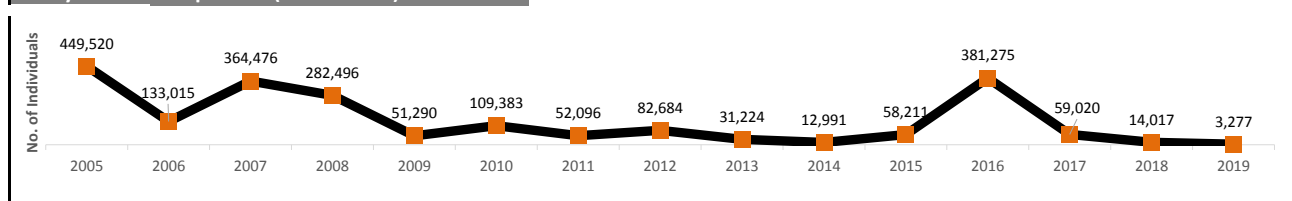
Weekly Trends - 2019



Monthly Trends Comparison (2017 - 2019)

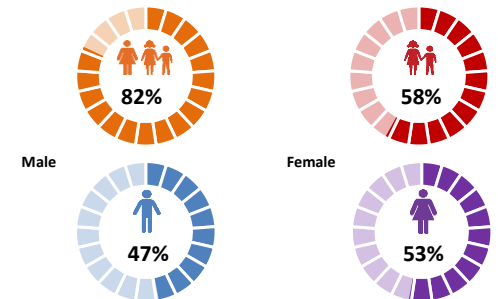


Yearly Trends Comparison (2005 - 2019)
