## **Information Management Session: Sector Dashboard**

## **Sector Gender Analysis**

Protection Sector Coordinators (including Child Protection Sub-Sector Coordinators and SGBV Sub-Sector Coordinator) provided their comments to the draft Protection Sector Gender Analysis. Protection Sector Gender Focal Points will make a presentation during the February monthly meeting and receive feedback from participants.

The Shelter Sector Gender Focal Points have continued to follow up with feedback with Sector Coordinators, so that they will be able to present the final reports to Sector Partners.

These final reports will be uploaded to the portal site, as done for other five sectors.

Livelihoods Sector Focal Points will meet with a UN Women Livelihoods and Gender Expert and discuss on the Gender Analysis on 1 February after the next monthly meeting.

It was reiterated that all the sectors would have to complete updating Sector Gender Analysis in a timely matter during the first half of the year, so that findings and recommendations will inform the next cycle of the planning phase in the mid-year.
