Persons of concern were readmitted from Niger and Rwanda to a previous country of asylum as refugees

Since 1 September 2017, **5,312** refugees were evacuated from Libya to Niger (**3,361**), Rwanda (**648**), Romania (**495**) and Italy (**808**). Between 1 September 2017 and 31 August 2021, **5,067** refugees were resettled from Libya (**1,705**), ETM Niger (**3,014**) and ETM Rwanda (**348**). During the same period, **349** persons of concern departed from Libya, Niger and Rwanda to third countries through Humanitarian Admission (**280**), Private Sponsorship (**47**) and Family Reunification (**22**).

Resettlement Quotas Allocated in 2021*

As of 31 August 2021, **9 States** have allocated quotas for new resettlement submissions from Libya, Niger, and Rwanda during the 2021 calendar year. These 9 States include: Belgium, Canada, Denmark, Finland, France, Netherlands, Norway, Sweden and the United States of America.

With these quotas, and subject to operational constraints associated with the COVID-19 pandemic, UNHCR plans to submit at least **6,900** refugees for resettlement, of which approximately **900** places will be used for submissions by UNHCR Libya, while approximately **1,565** places will be for submissions from the ETMs in Niger and Rwanda, and **4,435** will be submissions for other refugees registered in Niger and Rwanda.
