<b>Coordination update (JRP, AI, Survey results)</b>	<ul style="list-style-type: none"><li>- IM Monthly update:</li><li>- 14 organizations entered their monthly submissions on AI database. Reported activities will be implemented in 12 locations. However, some activities will</li></ul>	

	<p>cover all Jordanian areas (Country wide) as per the 2021 submission under AI tool.</p> <ul style="list-style-type: none"> <li>- Compared to 2020, there is more than 79% increase in reported achievements in 2021. 149% of the Total target was achieved for the first four indicators. 94% of clients demonstrated satisfaction towards GBV case management services they received.</li> <li>- Some GBV partners who appealed during the JRP 2020-2022 did not report on AI. Organizations who did not report were asked to report and to reach out if they are facing any problems.</li> <li>- Survey results: <ul style="list-style-type: none"> <li>- The results admitted by 18 respondents who answered the survey were presented by UNFPA.</li> </ul> </li> <li>- <b>Questions and Comments:</b> <ul style="list-style-type: none"> <li>- Question: JRF: Would organizations be able to edit the data entered previously? Would the system be open for doing so?</li> <li>- Answer: This will be reviewed, and organizations would be informed if doing so is possible.</li> </ul> </li> </ul>	
<p><b>2022 Workplan discussion</b></p>	<ul style="list-style-type: none"> <li>- The 2022 GBV SWG Work Plan was discussed thoroughly.</li> <li>- Q1 will involve a review and update of the workplan.</li> <li>- The workplan will be shared by email so that members can go through it provide their feedback and advise if they can support in any activity.</li> </ul>

A review occurred in August 2021 and the next review will be scheduled in August 2022</li><li>- Categories in the workplan that are done will be kept in the workplan, however, the expected outcome will be changed accordingly.</li><li>- No one requested an update on SoPs, but both the Arabic and English versions will be disseminated.</li><li>- Amaali App: A PPT will be prepared regarding the new features on the App.</li><li>- Organizations that wish to participate in the referral pathways should inform the WG Key Contacts.</li><li>- Most participants agreed that the safe referrals training should continue, whereas many people are still interested to partake in the training.</li><li>- If there is an issue with the safe referral training material, there are two functions on Amaali App that allow participants to submit feedback regarding any issues or issues with organizations.</li><li>- Updating the safe referral training material should be considered.</li><li>- Participants have acknowledged that there is no need for a new needs assessment, however, a needs assessment for national stakeholders should be added to the workplan. Whereas there is a need to assess the gaps in GBV services at MoSD and FPJD.</li><li>- The Gap Analysis and Guidance Notes will be updated and shared.</li><li>- The GBV sectorial strategy needs to be updated and shared more often.</li><li>- The issue of updating the assessment for capacity building activities will be discussed bilaterally via email.</li></ul> |  |

<b>ME toolkit roll out consultation</b>	<ul style="list-style-type: none"> <li>- An interactive questionnaire was presented and answered by all participants, results will be shared via email.</li> </ul>	
<b>Sub national WG- Field update</b>	<ul style="list-style-type: none"> <li>- Field staff presented their updates as the following:</li> <li>- Irbid shared 2021 achievements: <ul style="list-style-type: none"> <li>▪ Support service delivery:</li> <li>▪ Invited the legal service providers in Irbid (ARDD, NRC, IRC, JCLA and Tamkeen) to our platform and briefed the SWG members on the legal support that they are providing for CP SGBV cases (criteria and eligibility of the legal services, when providing legal advice, when providing legal representative, documentation cases, court fees, mediations, fines, etc).</li> <li>▪ Invited the livelihood service providers (ACF, IRC and NRC) and briefed the SWG members on the services that are provided.</li> <li>▪ To support the service delivery, we updated the referral pathway and 4Ws including the focal point, services, helplines... and updated GBV gap analysis.</li> <li>▪ Raise staff awareness:</li> </ul> </li> </ul>	

- Conducted SGBV safe referral virtual session which targeted more than 100 non SGBV staff.
- GBV risk assessment in Irbid:
- Our group members are engaged actively in GBV risk assessment which was organized Irbid by IOM on behalf of SGBV SWG. Irbid CP GBV SWG had an active and amazing role in conducting the FGD, the report was presented during one of SWG meetings and uploaded in UNHCR data portal in Aug 2021
- Joint virtual activities:
- Commemorate International women day, (UNHCR, NHF and IRC) presented some activities during the event.
- 16 days of activism: Sharing my story, my voice: My rightful access to opportunities and services, UNHCR, IRC, NRC,IRJ conducted activities in the event.
- Peer to peer cross learning
- On behalf of GBVIMS, AWO Presented their 2020 Annual Report GBVIMS, Number of achieved cases who have reported GBV Incidents, types of GBV incidents, Success, Challenges, and Recommendations.
- ILO Presented their project on Migrant Workers, Better Work in partnership with ILO & IFC, to improve work conditions especially in the Clothing Sector. They target 75% Female migrant workers & 25% Males. 18% of the Female migrant workers disclosed that Sexual Harassment is their concern. As well, they presented criteria, and faced challenges, and ask for a support from Irbid CP SGBV SWG members, to serve this category.
