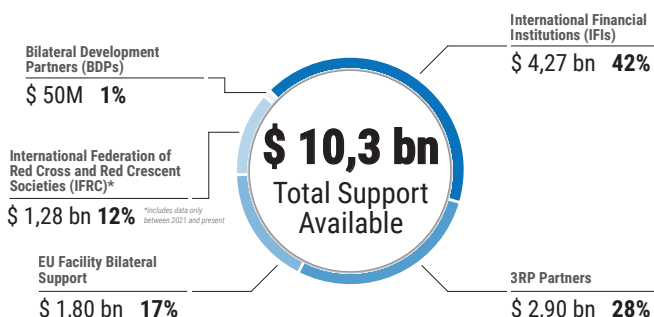


Support to Public Institutions by International Financial Institutions, 3RP Partners, and Bilateral Development Actors between 2017-2022

This dashboard aims to present a full overview of the support provided to Türkiye public institutions and private sector to host Syrians under Temporary Protection, International Protection Applicants and Status Holders. This encompasses support provided respectively by 3RP partners, by International Financial Institutions, and by other development actors. The below data includes interventions implemented since 2017 as well as on-going and planned interventions with secured funding. Only data related to support to public institutions and private sector are included, which means that support implemented directly by 3RP partners or through civil society is not reflected (but available through the regular 3RP financial tracking).

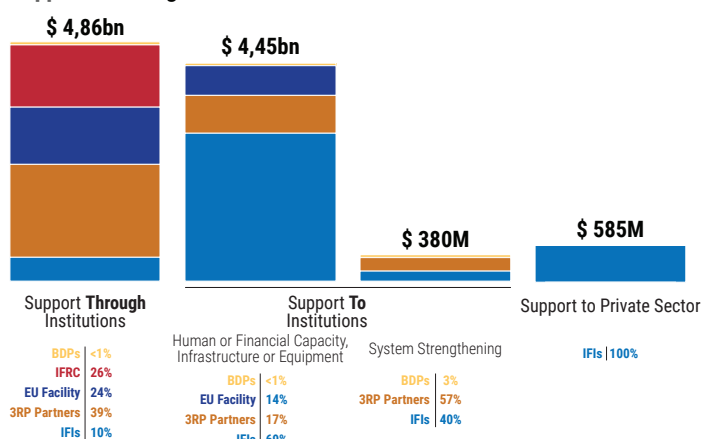
Data is categorized by type of interventions: support channeled through institutions to benefit individuals, support to institutions either in terms of financial/human resources or in terms of system strengthening, and support to the private sector and civil society. Data related on 3RP interventions are based on the reports of Public Institution Support Tracking (PIST) conducted since 2017. Data related to IFIs covers interventions from the World Bank, the EIB, the EBRD, KfW, ISDB, AFD, and JICA and includes both grants and loans. Bilateral development actors include Expertise France and GIZ. Data related to the EU Facility Bilateral Component is taken directly from the Facility Project List.

Total support available for Government of Türkiye

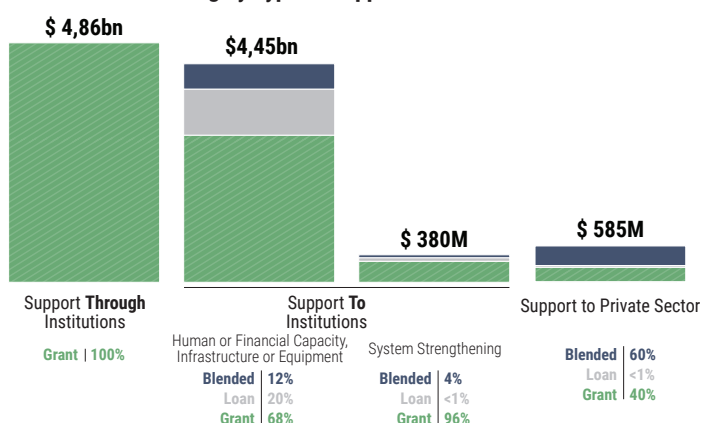


Type of support provided

Support to/through Public Institutions and Private Sector

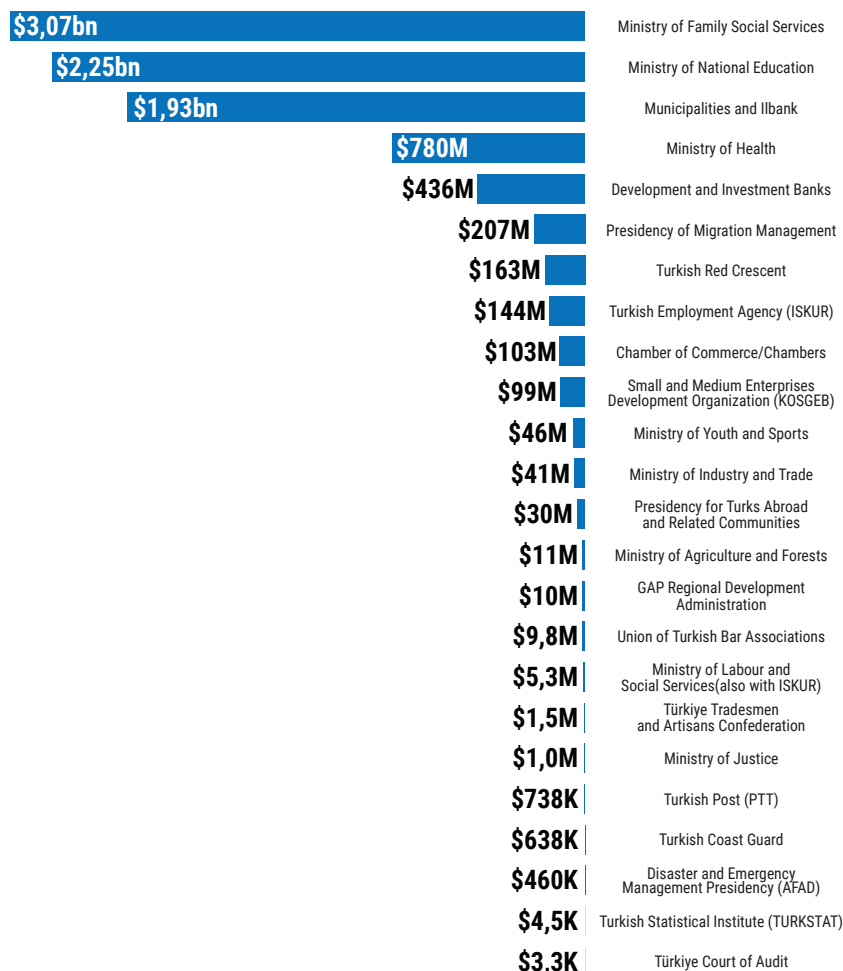


Nature of the Funding by Type of Support

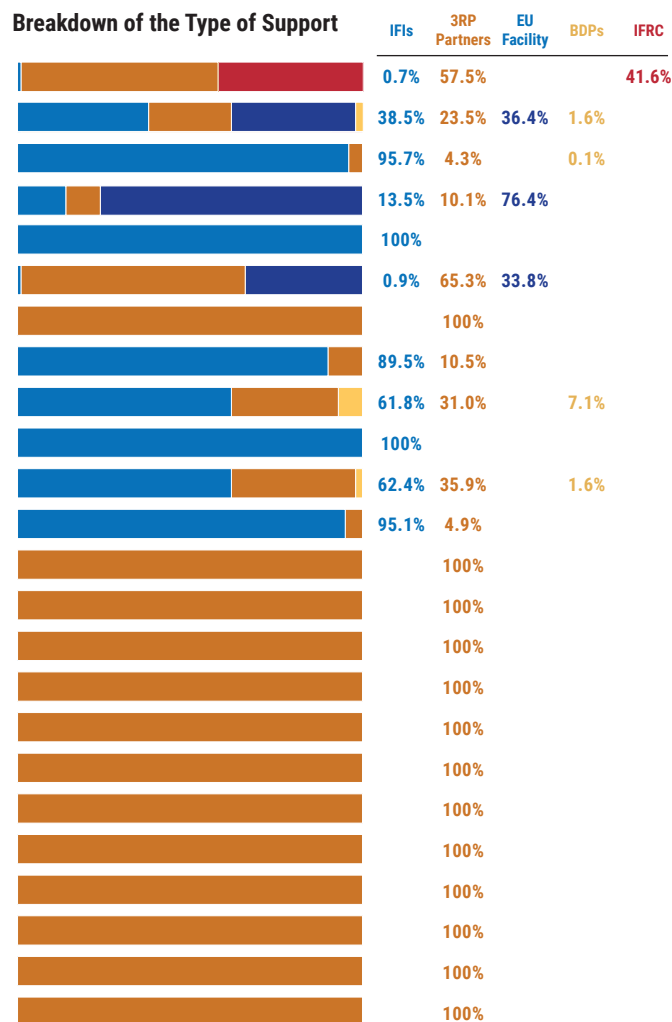


Value of Support provided to Public Institutions

Breakdown of the Funding Allocated

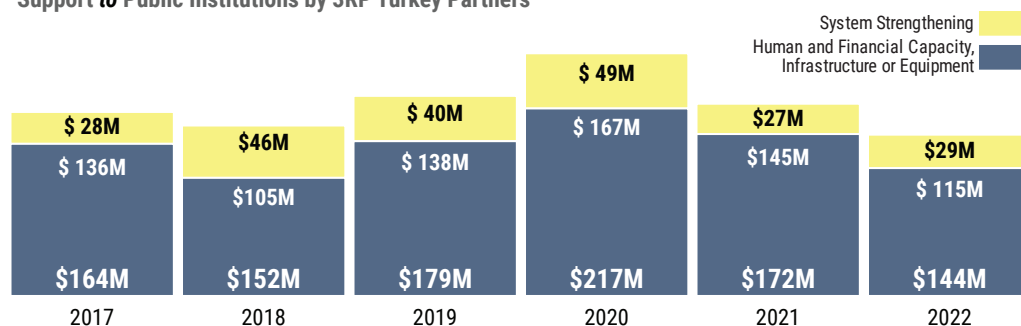

Support to Public Institutions by 3RP Turkey Partners

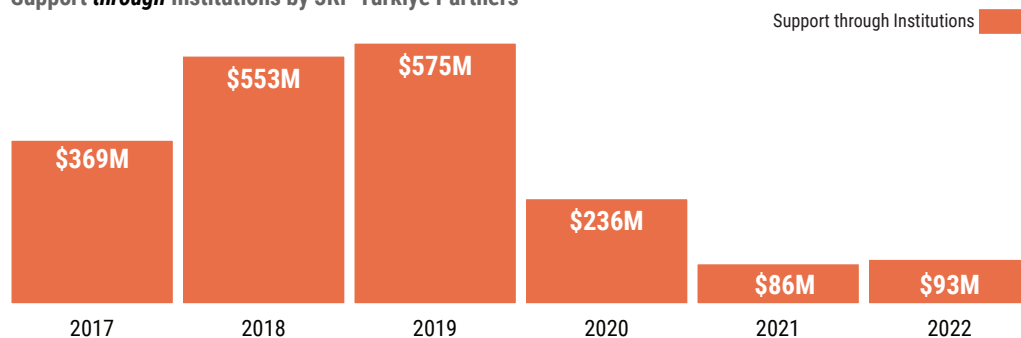


The findings confirm that the 3RP partners continue supporting public institutions even though the general trend on fund allocation is decreasing.

In 2022, 3RP partners have allocated **USD 144 million** to public institutions for projects to provide direct support with infrastructural capacity and strengthening the system capacity.

In total, since 2017 3RP partners have been providing more than **USD 1 billion** worth of support to public institutions in Türkiye to expand, improve and strengthen services and assistance to Syrians under Temporary Protection, International Protection Applicants and status holders, and host communities.

Support through Institutions by 3RP Türkiye Partners

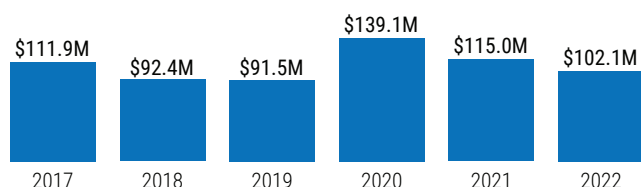


In addition, 3RP partners have been using national systems to deliver assistance. In 2022, 3RP partners have allocated **USD 93 million** worth of support through national and local institutions.

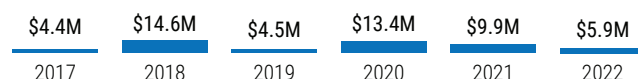
The decrease of funding channelled through public institutions is primarily related to the ESSN being implemented outside of the 3RP since 2020 - although the ESSN is still included in the 3RP coordination.

Evolution of 3RP Support by Institution between 2017-2022

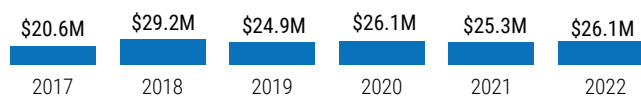
Support to Education Institutions MoNE, MoYS, YTB, GAP-RDA



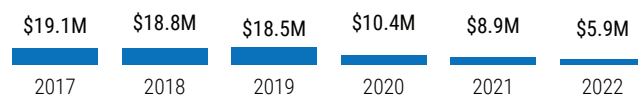

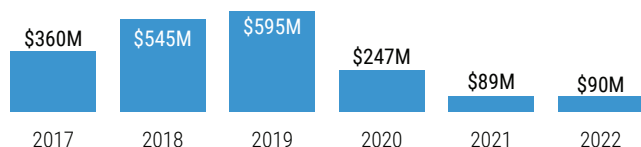
Support to Ministry of Interior and Rule of Law Institutions

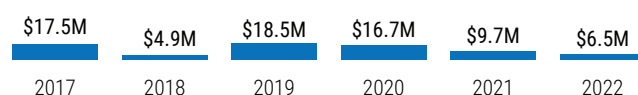


Support to Social Institutions MoFSS, TRC*

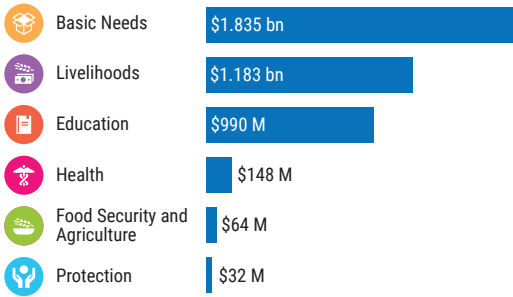

Geographical Coverage of the Support from IFIs*

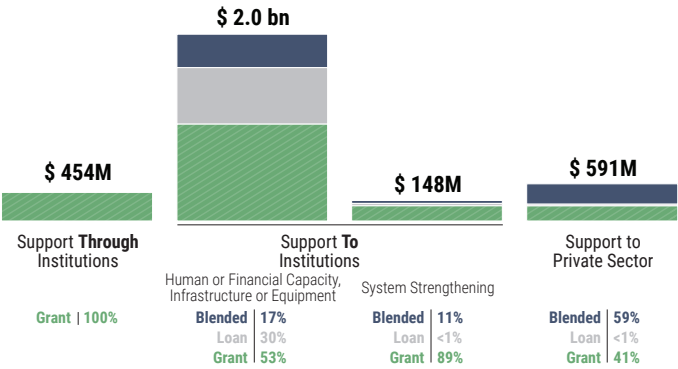

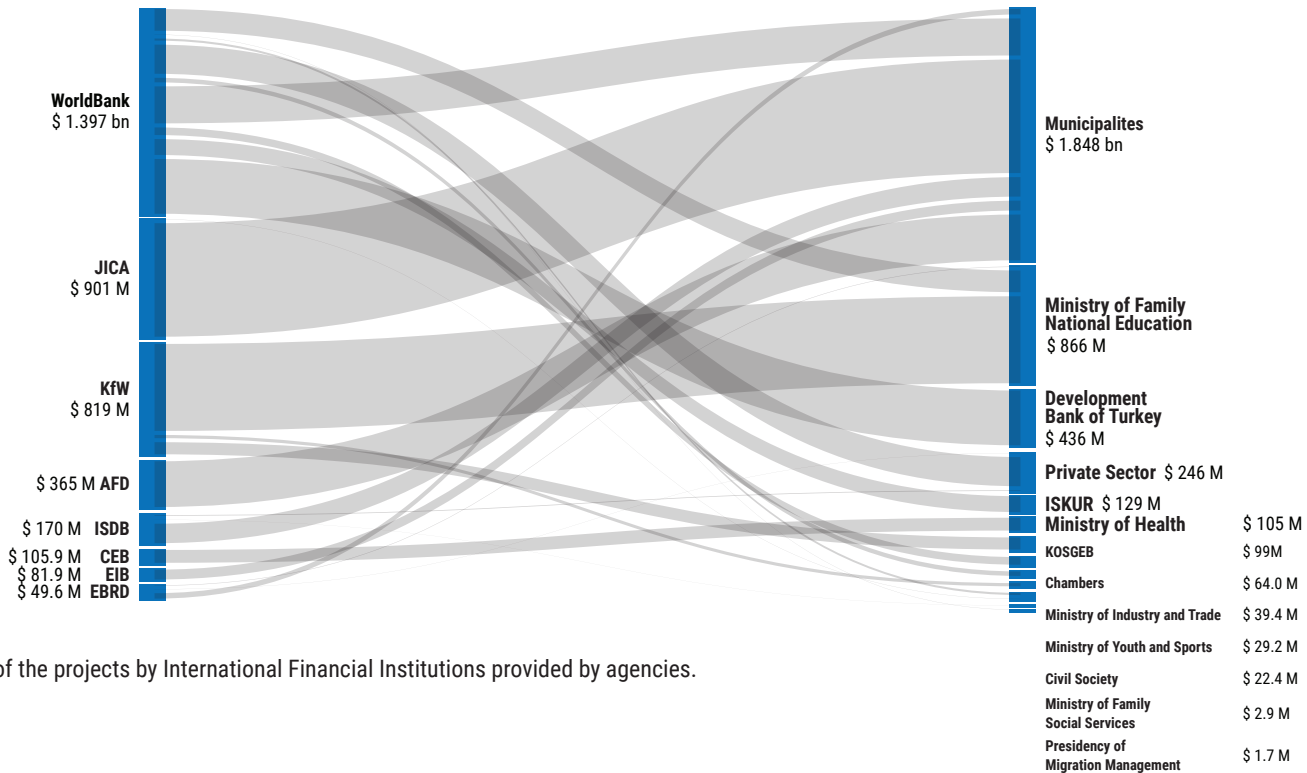
IFI support as per 3RP sectors
