<p>Stella Badin, Deputy Mayor of Cahul</p> <p>Elena Daud, District Council</p>	<p>The large number of Ukrainian men on the territory of the Republic of Moldova justified by the fact that they can apply for asylum when crossing the border. According to the national and international legal framework, no one can refuse a person's application for asylum.</p> <p>Elena Daud There are several complaints about men's posture inside RACs (parties, drinking alcohol, people screaming). The main concern is the men/refugee community outside the RACs and the risks for the local community.</p> <p>Activities to discuss issues surrounding masculinity and GBV prevention programs that engage men were suggested.</p> <p>Concerns were raised on how to approach, communicate, and pass information to the refugees on their duties/laws/obligations/consequences of their actions. A guidance on working with men and information material on rights and responsibilities/rules would be useful.</p> <p>Stella Badin Attention was brought to the fact that one training or workshop would not be sufficient to stop all the irregularities happening in the RACs or host communities. A strategy for the long term is expected.</p> <p>A survey with the host community to understand better the challenges and solutions to ensure peaceful coexistence would be of advantage.</p> <p>Refugee children be mandatorily involved in school and/or kindergarten because, in some cases, their parents do not take care about this issue.</p>	<p>Deadline: Till next meeting.</p>
