LRP Sector Results – ‘At a Glance’ Summaries – Q1 2025

A reduced version of the quarterly sector dashboards was developed this quarter, summarizing progress made by sector partners under the Lebanon Response Plan (LRP) for the first quarter of 2025. LRP Funding Update – Q1 2025

581 million USD was made available by Q1 2025 to partners for interventions under the LRP including funding directly received and carry-over/multi-year funding contributions made previously for 2025.

This equates to 19 per cent of the LRP partner appeal that was set for the year (2.99 billion USD).

The funding update is developed by analyzing and consolidating the figures shared by the LRP partners through the Lebanon Aid Tracking System at the end of each quarter.

Displacement Tracking Matrix: Mobility Snapshot – Round 86

The International Organization for Migration (IOM) conducts daily monitoring of population movements in Lebanon to support preparedness and response efforts. This is done in partnership with the Disaster Risk Management (DRM) Unit, technically supported by the United Nations Development Programme (UNDP), to triangulate and verify data from IOM's mobility tracking exercise and the Lebanese Red Cross (LRC) household registration exercise. As of 30 April 2025, Mobility Tracking data indicates that 970,470 internally displaced persons (IDPs) have returned to their communities and the total number of IDPs is 90,020. Given the complexity and fluidity of population movements in the country, these observed returns cannot be considered permanent and should be viewed as a snapshot in time, as many people remain on the move. UNHCR Snapshot: Syrian Returns & Movements – 15 May 2025

As of 15 May 2025, UNHCR estimates that 170,078 Syrians have crossed from or via Lebanon into Syria since 8 December 2024. A total of 112,396 Syrian individuals have been inactivated from UNHCR's registration records in Lebanon in 2025 due to verified or presumed return. Notably, 108,344 estimated new arrivals of Syrians into Lebanon have been monitored, with significant concentrations in Bekaa El Hermel, Akkar, and North governorates. In April and May, total entry and exit movements of Syrians at official land crossing points have been steady, with an upward trend in exits expected during the summer, particularly after the school term ends and as organized return programmes roll out. Lebanon Humanitarian Fund Annual Report – 2024

The Lebanon Humanitarian Fund (LHF) Annual Report outlines the Fund's strategic and flexible support to address critical humanitarian needs amid Lebanon's most severe crisis since 2006. In response to the escalating hostilities and complex humanitarian situation, the LHF launched three key allocations totaling over \$65 million, enabling a timely, localized, and multisectoral response across health, food security, WASH, protection, shelter, and more. Donor contributions reached a record \$80.4 million, vastly exceeding the resource mobilization target, and 42 per cent of funding was allocated to national NGOs, reaffirming the LHF's commitment to localization and principled humanitarian action. Regional Refugee and Resilience Plan (3RP) Annual Report – 2024

The 3RP is a strategic coordination, planning, advocacy, fundraising, and programming platform that brings together around 230 humanitarian and development partners across four countries, Türkiye, Lebanon, Jordan, and Egypt. Since its inception in 2015, the 3RP has channeled over US\$ 26 billion toward providing assistance and protection to, and support the resilience of, refugees and host communities. The 3RP adopts a tailored approach to address country-specific needs and priorities, guided by the principle of leaving no one behind. This 2024 report presents an overview of 2024 population figures, achievements across the four strategic directions, updated funding figures, and regional engagements. Protection Monitoring Report – Q4 2024

The ongoing Protection Monitoring Report is conducted by UNHCR to analyze trends in the protection environment and risks facing refugees. This is implemented at the regional and at the national levels by UNHCR's protection monitoring partners. Partners conduct interviews with refugee households and key informants to gather their feedback on the overall protection environment in Lebanon. UNHCR External Report: Lebanon Community Dialogue on Return and “Go and See” Visits – May 2025

Between 4 March and 9 April 2025, UNHCR and partners met with close to 600 women, men, youth, female-headed households, older persons and persons with disabilities covering all governorates in Lebanon. Outreach Volunteers, Disabled People Organizations and other community-based organizations were also consulted. The aim was to seek the community's views on returns and “Go and See” visits in order to inform the design of programmes and activities. The community dialogue is one of the many ways UNHCR ensures that your feedback informs decision-making.
