LRP Funding Update - Q3 2025

\$928 million was made available by Q3 2025 to partners for interventions under the LRP including funding directly received and carry-over/multi-year funding contributions made previously for 2025. This equates to 31 per cent of the LRP partner appeal that was set for the year. The funding update is developed by analyzing, consolidating and validating the figures shared by the LRP partners through the Lebanon Aid Tracking System at the end of each quarter. Referral Trends Report - Q3 2025

The referral trends report provides a comprehensive overview of partner referral reporting and aims to identify referral trends and bottlenecks. These results have been produced following rigorous follow-up with partners and thorough data cleaning, ensuring they accurately reflect quarterly reporting findings. Referral trends integrate insights from RAIS, RIMS, and other referral management systems, which are captured and presented in ActivityInfo. The charts are designed for sector presentations to share progress updates, encourage informed discussions among actors, and enhance the overall response to referrals. Contingency Stock Trends Report - Q3 2025

The contingency stocks trends report provides a comprehensive overview of the current stock levels across Lebanon, detailing warehouses, items, agencies, and locations of various stocks, including those designated for contingency purposes, as reported by response partners in ActivityInfo. The report is designed to facilitate identification and management of stock allocations, and to enhance overall coordination. Partners are encouraged to add/update their stocks and include warehouse locations in the Contingency & Preparedness Tool on ActivityInfo on a regular basis as part of joint emergency preparedness activities. Service Mapping Dashboard - 2025

The service mapping dashboard provides a visual representation of the updated services as reported by response partners in ActivityInfo. This ensures a comprehensive overview of available services and assistance, providing timely support to individuals in emergency situations, and enabling stakeholders to identify service gaps and areas in need of additional support. UNHCR-Supported Voluntary Repatriation of Displaced Syrians in Lebanon - 31 October 2025

This overview was prepared by UNHCR to provide an update on the Voluntary Repatriation (VolRep) of Displaced Syrians in Lebanon. Since January 2025, 335,749 Syrian individuals known to UNHCR have been inactivated from UNHCR's database due to confirmed and presumed returns to Syria. By the end of October, a total of 32,093 Syrian individuals known to UNHCR underwent the facilitated VolRep programmes, including completing voluntariness assessments, issuance of Repatriation Forms, and provision of a return cash grant of \$100 per returning individual. 112,899 Syrian individuals (21,000 cases) have expressed interest and remain in the pipeline for the UNHCR-facilitated VolRep program. UNHCR and IOM have also facilitated 7 organized return movements of 1,476 Syrian individuals through Arida and Masnaa borders to Rural Damascus, Damascus, Homs, Hama, Idlib and Aleppo. A schedule of 7 further organized return movements for the remainder of the year is also being scheduled. The latest update on VolRep is available here.

WaSH in Informal Settlements and Collective Shelters: Advocacy Note – 2025 The advocacy note, prepared by the WaSH sector, highlights that \$14 million is required to deliver critical life-saving services for the most vulnerable displaced Syrians in prioritized informal settlements and collective shelters in 2026. Despite more than a decade of Syrian displacement, humanitarian WaSH services, including water trucking and desludging, remain the only viable life-saving services to ensure minimum access to safe water and sanitation in the majority of informal settlements and collective shelters.
