Introduction

- Shelter and WASH partners for South region, as well as Water Establishment for South and Representative of Wash Establishment of Tyr, were mobilized to discuss results of recent mapping exercise; outcomes of undertaken assessments and further divide and assign responsibilities.

Results of ITS Mapping

- Mapping of ITS currently identified in South region has been consolidated, updated map was presented to partners;
- Current mapping level revealed that ITS located in Al Wazzani was left out;
- Interventions in this particular area so far include:
 - MC: Distribution in Al Wazzani ITS (Sahel Sarda) hosting 5 HH (non-registered);
 - CISP identified ITS in Al Wazzani near LAF checkpoint (16 tents); plans to undertake WASH interventions;
 - Wata Al Khiyam ITS previously assessed by Shelter & WASH sector;
- Action points:**
 - For Al Wazzani: UNHCR FO gather existing assessments undertaken in ITS, fill assessment gaps if needed; assign respective responsibilities to tackle identified gaps.

Erbil-al-Saki Municipality (Marj-al-Khokh ITS)

- UNHCR FO shared outcomes of the recent meeting with municipality of Erbil-el-Saki: UNHCR FO and municipality acknowledged the high risk of contamination of water source underneath the ITS if no WASH intervention is undertaken promptly. All though relocation of the population to diminish the risk is best option, little chance to have the population agreeing on this solution considering that the site exists since 2001.
- At short term and in seek of disaster prevention, municipality of Erbel-el-Saki approved necessary WASH interventions without further delay.
- Action points:**
- CISP and AVSI to start respective WASH interventions according to areas of interventions agreed upon between both organizations;
- UNHCR FO to further discuss with Erbil-al-Saki municipality the accepted level of shelter intervention as preventive action for the winter.

Planning WASH & Shelter interventions

- UNHCR FO presented a brief overview of available services and gaps identified in 4 ITS (Marj-al-Khokh, Babilieh I & II, Zahrani (seaside)) and 3 ITS/CS (Ras-al-Ain, Abou Alaawi, Abou Rabih);
- Action Point:** UNHCR FO, in consultation with partners, to divide and assign responsibilities for each site to facilitate adequate and prompt intervention
