

Winterization

Standard NFI Winterization Package

- \$100 cash (card or voucher) per HH per month x 5 months
- \$50 cash in lieu of a heater (or an in-kind heater, costing \$50-100)
- High thermal (HT) blankets – 1 per person

Newcomers


- Standard newcomer package of blankets (1 pp), mattresses (4), kitchen set, hygiene kit, baby kit, food parcel, plus...
- \$150 extra cash, to cover period till registration
- If eligible, HH could receive standard package (when registered)

Shelter (for 10,000 HH through the winter)

- Weatherproofing kit for unfinished buildings (~\$200 per HH)
- Weatherproofing kit for informal settlements (~\$200 per HH)

Current Resourcing – Overall

- ❖ Total caseload 90,000 HH (450,000 indivs.)
- ❖ UNHCR plans to support all vulnerable registered living above 500m = 63,600 HH (318,000 indivs.), for a total cost \$41m
- ❖ UNHCR currently has \$26M for NFI winterization – sufficient for all needs this year, but it needs \$15M for Jan-Mar next year
- ❖ UNHCR will implement its programme through 7 partners (DRC, WVI, SCI, Makhzoumi, ACTED, Caritas, CISP, SHIELD)
- ❖ 17 other agencies (IRC, NRC, SCI, Oxfam, HI, GVC, IOM, Red Cross, Medair, AVSI, WVI, Humedica, SIF, AMURT, CARE, Mercy Corps) are funded to cover an additional 25,300 HH
- ❖ The shortfall is therefore $90,000 - 88,940 \text{ HH} = 1,060 \text{ HH}$ (x \$640 @ = \$678,400)

Next Steps for UNHCR

UNHCR Programme:

- Allocate 63,461 HH worth of funds ($\$325 \times 63,461 = \20.6M for needs in 2013 + $\$315 \times 63,461 = \20.0M for 2014)
- Amend agreements with DRC, WVI, SCI, Makhzoumi, ACTED, Caritas, CISP, SHIELD, resourcing according to caseloads per area

UNHCR Supply:

- Of the 2013 figure, \$3.2M is for procurement of HT blankets
- Ensure 318,000 HT blankets / quilts are received & delivered to the above IPs by end Oct, according to their caseload per area
- Allocate & deliver 1st tranche of 6,000 diesel stoves; continue to push on with procurement of 2nd tranche of 14,000 stoves


UNHCR Area Offices








Number of Items Distributed per District (From January to August, 2013)



NFI Newcomer Programme - Comments

- UNHCR is not part of the newcomer programme, i.e. it does not supply these NFI kits, except on an ad hoc emergency basis
- Not all geographical areas are covered by an NGO funded by ECHO to implement the newcomer programme
- Not all NGOs, even those funded by ECHO, provide exactly the standardized package
- Newcomer Hygiene Kit = same as Hygiene Kit distributed each month to registered refugees, except for non-consumables:
 - toothbrushes, comb, laundry line, garbage bags, buckets + lids
- Baby Kit = same as the one distributed to registered refugees
- UNHCR's Hygiene Kit contains only consumables; it costs \$14
- UNHCR's Baby Kit costs \$11 (inc. VAT)
- Almost certainly the reporting of Hygiene/Baby Kits is incorrect.

Health & well-being of asylum-seeking pop. assured through attainment of basic living standards

1. Cover winter needs by providing the identified beneficiaries (from the registered refugee, unregistered refugee, Lebanese returnee & host community population) with assistance to enable them to survive winter without adverse effects:
 - a. For 3 months only, Jan-Mar 2014
 - b. For 2 months only, Nov-Dec 2014
2. Cover winter needs by providing newcomers, whether Syrian, Lebanese or PRS, with assistance to enable them to survive winter without adverse effects.
 - a. For 3 months only, Jan-Mar 2014
 - b. For 2 months only, Nov-Dec 2014
3. Cover emerging needs of all newcomer refugees from Syria (whether Syrian, Lebanese or PRS) with a minimal set of bedding & the means to cook, eat & maintain hygiene, & emergency needs of newly discovered families so far unsupported, once assessed.
 - a. For 6 months, Jan-Jun 2014
 - b. For 6 months, Jul-Dec 2014
4. Cover contingency needs by establishing/maintaining a reserve stock of essential NFIs, to be a buffer sufficient to cope with a mass influx of twice the normal number of new arrivals in one month (i.e. 150,000 individuals).
