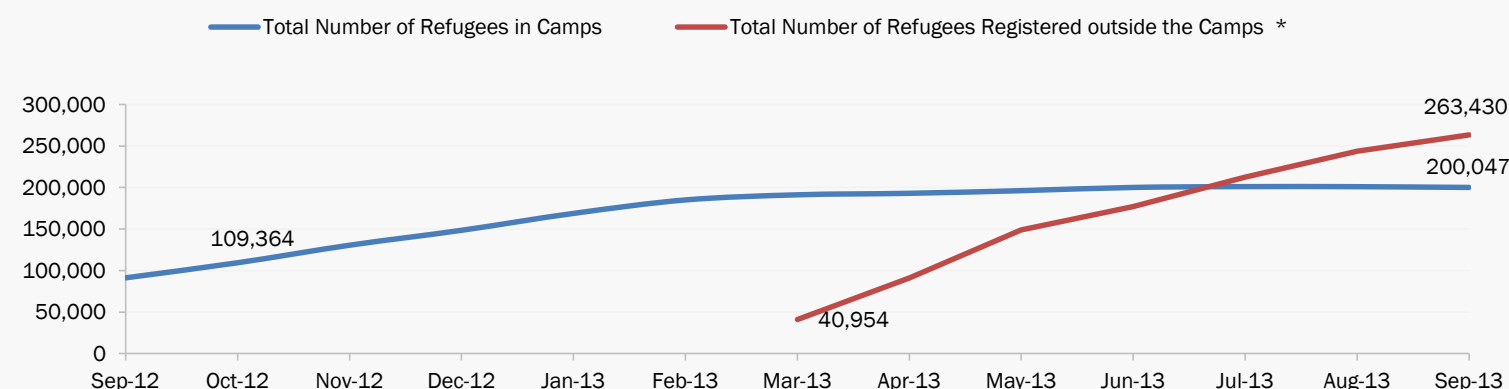
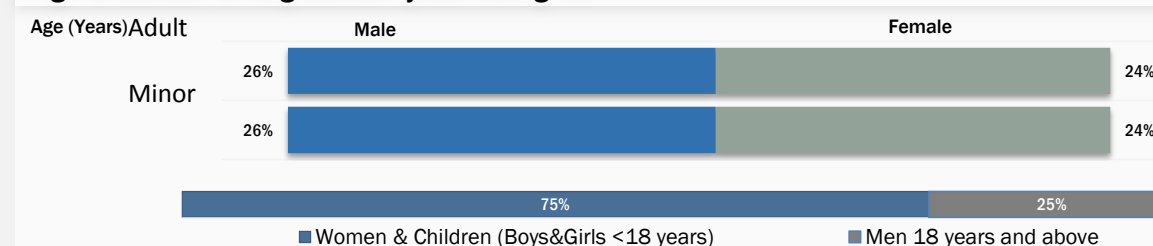

## Highlights

- On 07 October 2013, AFAD - the Disaster and Emergency Management Agency of Government of Turkey - announced that the total number of Syrians registered and assisted in 21 camps in 10 provinces was 200,007 including 667 Syrians receiving medical treatment in hospitals. AFAD reported that during the 24hrs of 06-07 Oct. 2013, a total of 497 Syrians were admitted and registered in the camps and 625 Syrians have voluntarily returned to Syria.
- In Kilis local officials started to move non-camp Syrians living in the parks to the transit center as of 07 Oct. 2013. On Monday 07 Oct. 2013, initially a few hundred of people from the open area /land across from the Provincial Administration building were moved. Reportedly, there were a few thousand Syrians living in makeshift tents without any sanitation facilities in the area. It was reported by officials that the relocation of the non-camp Syrians in Kilis will continue until the capacity of the transit center is full. Officials informed UNHCR that in total more than 3,000 people are planned to be accommodated in the center. A UNHCR Field team was present in the transit center when the first people have arrived and it was observed that while some people were happy about the situation/conditions others were less so. UNHCR Field Team will continue to observe the situation.
- Upon request from camp managers and in cooperation with AFAD, UNHCR purchased wheel chairs to be provided to the disabled Syrians in the camps. The first batch of wheel chairs provided by UNHCR is being delivered to the camps. In addition to the wheel chairs, UNHCR also provides support to vocational training courses. The second batch of vocational items, which includes sewing machines, is being delivered to the camps and it is expected to be completed during this week. UNHCR also continues to cover the cost of exceptional medical interventions, such as concerning a child in Akcakale camp, who was in need of a prosthetic eye.
- UNHCR has been advocating with the officials to apply Turkish law in the event of any wrong-doing by Syrians in the camps. In Adana Saricam camp, officials informed the UNHCR Field Team that they have referred a perpetrator of domestic violence to the public prosecutor who sentenced him to a restraining order to stay away from his family's tent for a month period. The man is allowed to stay in the camp. In another case, a trouble maker was sentenced to a cash fine, which was suspended on the condition that he will not repeat the same behavior.
- In Adana Saricam camp, the officials informed the UNHCR Field Team about their challenges in having crowded classrooms in school and their need for stationery for the children. The officials also informed that they are having challenges in finding the education course books.
