NEEDS

Increased registration capacity, including the establishment of new registration centres and biometrics.

Establishment of decentralized shelter facilities for SGBV survivors, children at risk or vulnerable Syrians in need of shelter for other protection reasons.

Increased establishment of community centres/spaces benefitting host and refugee communities.

Increased information dissemination, awareness-raising & community outreach activities in urban areas & camps.

OBJECTIVES

The Inter-Agency Protection Strategy in Jordan is centred on (i) ensuring access to basic rights, including asylum and timely access to registration and documentation as a pre-requisite for proper protection delivery; (ii) expanding community outreach and development of community-based protection mechanisms; (iii) mitigating and reducing the risks and consequences of SGBV; (iv) ensuring that emergency child protection interventions are strengthened and harmonized; (v) responding to the needs of Syrians and vulnerable host community populations through provision of social, psycho-social and economic support; and (vi) exploring third country resettlement options as a protection response to cases with special needs or vulnerabilities.

ACTION/OUTPUTS

- 1 Syrians are able to access the territory, to seek asylum and be protected from refoulement
- 2 Syrian protection needs are addressed through targeted protection interventions (including Child Protection and SGBV), community mobilization and capacity building
- 3 Respond to the needs of Syrians and vulnerable host community populations with an emphasis on women and children through provision of social, psycho-social and economic support
- 4 Refugees, host communities and organizations involved in the refugee response are provided with adequate information and take part in awareness-raising activities
- 5 Third country resettlement options are explored as a protection response to cases with special needs or vulnerabilities

KEY SEPTEMBER DEVELOPMENTS

- UNHCR completed the classification of all 175,784 Syrian identity documents belonging to 124,257 individuals held in Rabaa Al Sarhan; classification of new documents continues
- Refugees are now registered on the same day at UNHCR's Registration Centre in Irbid, a significant reduction from a 6 month waiting period
- 3 Community Centres and 9 Community Action Committees, with the objective of serving 50% Syrians and 50% Jordanians in host communities, were formally established across the Kingdom
- The Forced & Early Marriage Task Force held the first awareness-raising session for religious leaders in Zaatari and is developing a standard training package for awareness-raising sessions on forced & early marriage
- The CP SWG organized a workshop to contextualize the Minimum Standards for Child Protection in Humanitarian Action to the situation in Jordan, with active participation from CP SWG members and Government officials.
- UNHCR met the first portion of its target, and submitted 100 vulnerable persons for resettlement in Sep. 2013.

ACHIEVEMENTS TO DATE



56,723 Syrian refugees registered in Sep. 2013; 23,460 Syrian refugees renewed their certificates in Sep. 2013



3,049 UAC/SC and children at risk (**1,747 girls and 1,302 boys**) received multi-sectoral services - [154 girls and 235 boys in Sep. 2013]



2,293 SGBV cases supported or referred - 1,995 females (1,360 women and 635 girls) and 298 males (156 men and 142 boys) - [561 females and 220 males in Sep. 2013]



7,173 individuals with specific needs received special support (3,397 females and 3,776 males)



96,368 children benefited from psycho-social support - (55,805 girls and 40,563 boys) and 11,454 adults (9,102 women and 2,352 men) - [6,010 girls and 4,217 boys in Sep. 2013]



86 child and youth friendly spaces and 24 women safe spaces operational



6,603 Government officials, civil society and humanitarian workers trained on refugee protection, Child Protection and SGBV


