- Supply chain in Zatari camp still unchanged, only minor changes might occur if new arrivals were transferred to other locations.
- In Cyber City; Hygiene kits and diapers replenishment are by far an operational priority. Second priority would be the replenishment of mattresses. Expected in future additional types of NFI request including kitchen set replenishment and fan-requests. In case funds would be available, it would be great if an NFI reserve could be in calculated for these type of matters.

Attendees informed about UN women visit to spread message for gender-sector-based issues, and it has been agreed that many donors would like to see gender markers within future proposals
