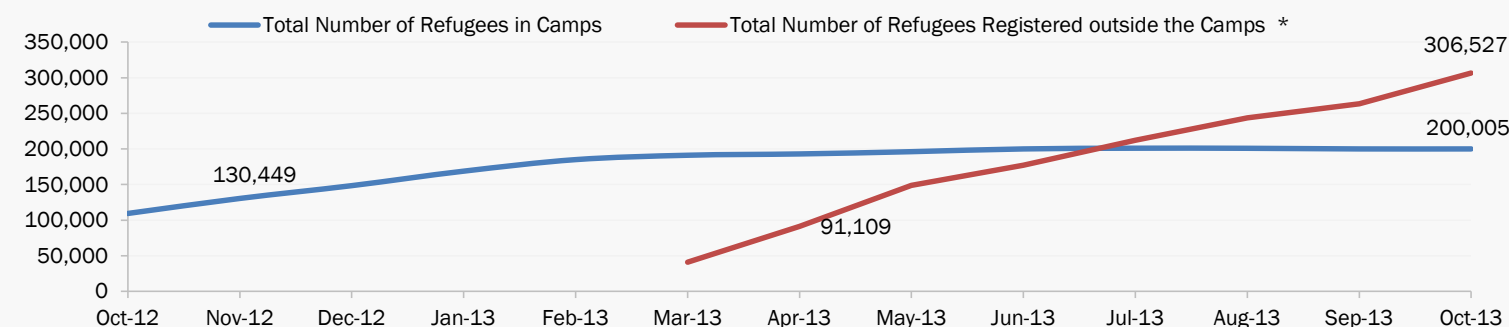

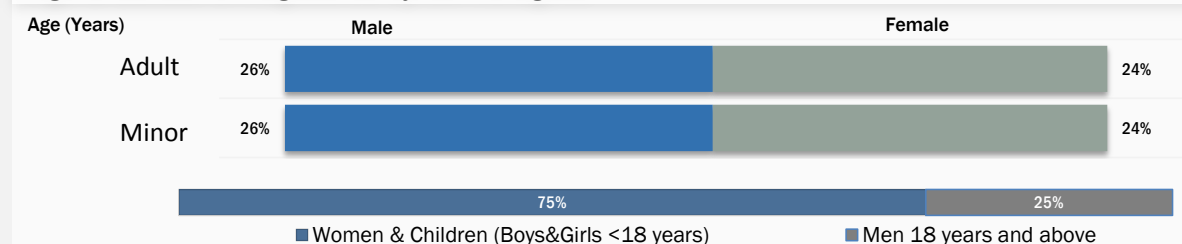

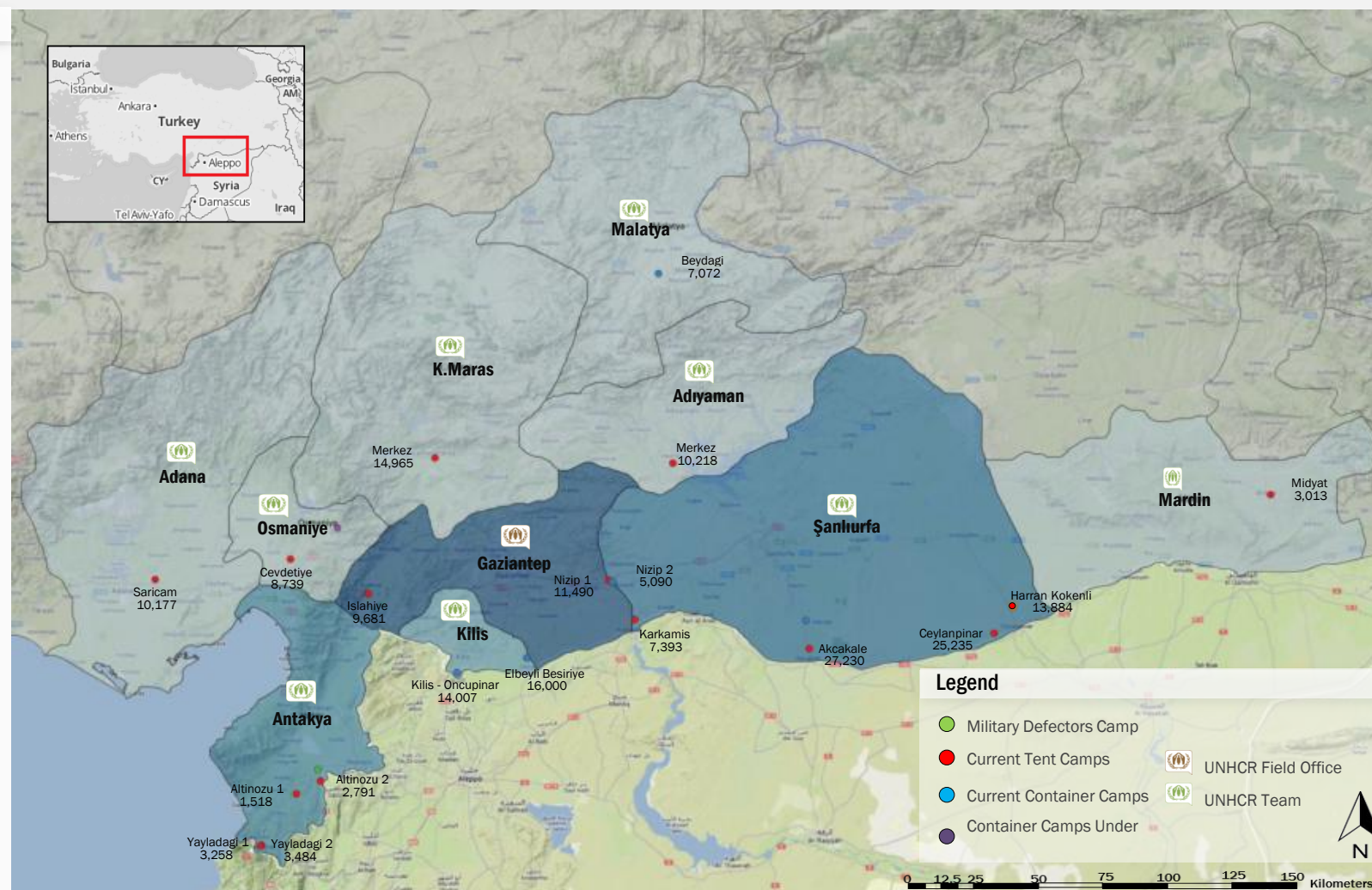


## Age & Gender of Registered Syrian Refugees



## Highlights

- On 29 October 2013, AFAD - the Disaster and Emergency Management Agency of Government of Turkey - announced that the total number of Syrians registered and assisted in 21 camps in 10 provinces was 200,005 including 58 Syrians receiving medical treatment in hospitals. AFAD reported that during the 48hrs (27-29 Oct 2013), a total of 829 Syrians were admitted and registered in the camps and 645 Syrians have voluntarily returned to Syria.
- In Kilis Elbeyli Container site, the camp officials of registration unit informed UNHCR that the camp's actual population is already over 20,000 however due to the technical problems of the initial software used to register the residents, those who are on leave or on daily permission out of the camp, could not be detected when they generate the camp's population breakdown thus the camp's real population is not accurately reflected. Reportedly it is expected that the problem will be solved with the new registration software that is used by the police which all the residents are re-registered and fingerprinted.
- In Elebeyli container site, the camp management informed that within the preparedness for winterization, they have distributed some 3,000 heaters and additional 2,000 were received from a Turkish NGO which will also be distributed. It was also reported by the camp officials that the two new boreholes were activated which solved the water shortage in the camp. Reportedly during the Eid period, despite the instruction of the sub-governor, the supermarket owners closed the supermarkets without informing the camp residents in advance which caused a severe reaction from the camp residents and they set one of the supermarkets on fire. Luckily no casualties and the situation is under investigation by the public prosecutor. The second supermarket which was completed has been opened and another one is under construction.
- Turkish Ministry of Education informed the camp officials through a circular in Sept. 2013 that qualified Syrian teachers will be allowed to work in the camps on voluntary basis. Reportedly the Syrian teachers will be under the supervision of the Education Director in the camps. The curriculum will be prepared by Supreme Education Commission of the Syrian National Council but will be under the supervision of Turkish Ministry of Education.
- Camp officials informed UNHCR that they received the names of the potential Syrian doctors and pharmacists who will be working in the camps. The camp officials are preparing the necessary documents including their petitions that they will be working voluntarily however some of these doctors reported that they were told to be paid through an NGO called Orient who also identified the names and recommended to Ministry of Health.
