Situation update and RRP prioritization</p> <ul style="list-style-type: none"> • The influx rate has now reduced with +/- 1000 refugees daily. • Zatari camp is now hosting ≈115,000 and more than 378,000 refugees in host community. • MOH decision regarding free access of Syrians refugees free of charge still valid but MOH is now considering revising the policy as the cost now reached more than 10 Million JD. • Bailing out system and departure from Zatari still working ; verification activity will be undertaken shortly. • Prioritizing health activities has been requested into 3 categories; essential, priority and resilience • Agencies requested to send their prioritization under their working group in order to be compiled by UNHCR . • There will be a meeting at UNHCR to discuss the Syrians in the Jordan valley 	<p>AP.(1): Agencies interested in Jordan valley meeting should contact Ibraheem (UNHCR).</p>

Health Sector assessment updates (MoH/WHO)</p> <ul style="list-style-type: none"> • Health Facility assessment started by MoH supported by WHO • Data collection finished by June 26th, and results will be shared mid-July. • The assessment will follow the Total Quality Management methodology, through a steering committee identifying the variables coming from the collected data • Health Facility Assessment will include Mafraq, Zarqa, Irbid, Ramtha, Jerash and Ajloun Governorates. Health facilities in Amman and those affiliated to NGOs will be covered later on. • Assessment will evaluate health facilities in terms of the number of the available beds, human resources, type of services provided, basic facilities, staff category and specialty, and the actual proportion of Syrians accessing the facility. • The goal of the assessment is to know the actual burden on health facilities in these areas, and to know who the recipients of the health services are. • Data will be collected through 2-3 data collectors for 3 days in each facility and will be using the retrospective approach in the hospitals, and the prospective approach in clinics and emergency rooms at hospitals 	<p>AP.(1): IRD (Health facility support) and WHO (EWARN project) to share the list of health facilities they are targeting in Irbid and Mafraq.</p>

Measles in Jordan</p> <ul style="list-style-type: none"> • The coverage in Mafraq near to 100 %; Target group is 6 months- 15 years for measles, and 16 months -59 months for Vit. A • Next week an outreach campaign in Irbid will start vaccination • Will be targeting all nationalities including Jordanians, Syrians, Iraqis, and others • The numbers of cases confirmed to have measles are 16 cases from Zaatari. 	<p>AP (2): UNICEF to Follow up on management of vaccination campaign medical waste.</p>
<p style="text-align: center;">6. EWARN project with MOH /WHO</p> <ul style="list-style-type: none"> • CDC mission is assessing the system now jointly with WHO to look for gaps and possible improvements. • NGO clinics will be added later once MoH pilot finished.

Camps update -Azraq (IMC), EJC (ERC) , Za'atri (UNHCR)</p> <ul style="list-style-type: none"> • EJC Registered refugee 3,294, vaccination for new arrival and EPI is going on, no significant health concerns as per ERC feedback. • Azraq Camp: IMC has demarcated the land for the PHC, staffing and medications procurement issues are still in process. 	<p>AP.(3): UNHCR to follow up on</p>

<p>UNHCR found support for a hospital from IFRC and they will start to deploy the hospital</p> <ul style="list-style-type: none"> • Zataari Camp: Mortality rates stable. No measles cases , number of bloody diarrhea decreased • Refugee reception, registration and medical screening will be moving to Raba Sarhan. • JHAS will handle referral cases in Azraq camp to Zarqa and Totanji governmental hospital. 	<p>increased cases of hepatitis being reported from Za’atari</p>

Sub sector working groups briefing</p> <p><u>Mental Health IMC</u></p> <ul style="list-style-type: none"> • MHPSS assessment in Zaatari will start in one month using UNHCR/WHO toolkit; Agreement have been signed by IMC and WHO with EMPHNET for MHPSS assessment • Updated psychosocial document will be shared for Azraq Camp. <p><u>RH</u></p> <ul style="list-style-type: none"> • MISP assessment team has finished the final draft of the beneficiary report which will be shared with the different health partners • IFH and JHAS are developing ANC awareness messages <p><u>Nutrition (UNHCR)</u></p> <ul style="list-style-type: none"> • Approval received from JFDA for importation of nutritional products to manage acute malnutrition. • Waiting for written approval of protocols from Ministry of Health • UNICEF and SCJ start SAM and MAM treatment in Za’atri and then outside of camp. • 40 cases of SAM managed in MSF hospital in Za’atari camp. • Mass MUAC screening results show GAM of 2.8% in Zaatari. 	<p>AP.(4): UNFPA to share English version of RH IEC material.</p>

Partners Updates</p> <ul style="list-style-type: none"> • IFRC through support of different Europe RC will deploy a Hospital in Azraq refugee camp. • ICRC Jordan will start training sessions in Za’atari camp for border guard medical services in eastern border (Dressing and stabilization) and first aid procedures. • GSF stop activities in Za’atari camp because of relocating. • JHAS start to provide normal deliveries services for upcoming 2 weeks. 	<p>AP.(5): IOM to share the contacts for agencies to call if they see TB suspect cases.</p>
