UN Agencies outside Syria can apply on exceptional basis – a need, a gap, etc. This will be taken to the Humanitarian Coordinator. The participation of national NGOs is very low in the ERF in Jordan. OCHA requested partners to encourage national partners to engage in the ERF.</p> <p>For outside Syria, there are two windows. One opened in June 2013, and proposals can be submitted at any time and are assessed on a rolling basis. The second window is a call for proposals. ERF will review proposals against approval criteria And then send to the Sectors for technical review.</p> <p>Partners are encouraged to coordinate with the Sectors. In 2014, there should be a call for proposals open by Thursday 24 April. ERF have received Sectorial priorities, for ERF to assess proposals against. Agencies have to submit proposal to OCHA and Sector Lead simultaneously. Once review by Sector, then review board – UNHCR, UNICEF, IRD, MercyCorps, UN -Women.</p> <p>The ceiling of the projects is 500,000 USD. For new NGOs, prefer not to exceed 250,000. The duration is up to 6 months. Partners are welcome to contact Amani from OCHA salah1@un.org or SGBV SWG leads for further information.</p> <p>Partners are requested to provide nominations for technical review committee for proposals to chairs.</p> <p>The ERF call for proposal is intended to complement the RRP6 priorities, by filling gaps left by the RRP6. Campaign materials will be distributed to partners.</p> <p>It has been found that social media and online messaging have the widest reception of Syrian refugees. Zain has been distributing sim cards to Syrians in Zaatari.
