SUMMARY of the MEETING/MINUTES

1. Review Action Points from previous minutes:

Minutes and action points were endorsed.

2. Partners' plans for 2015

All partners informed the group that their plans remain the same for 2015 as they were for 2014. SCI stressed that there will be no expansion to the number of KG facilities throughout the camp.

3. Work in groups on draft 2015 work plan.

The EWG split into two groups to work on updating the 2014 work-plan to make it adaptable to 2015. Some activities were removed, while others were just updated. One group worked on coordination, capacity development, and Information Management. The second group worked on CP, WASH, Health and Nutrition and Inter Sector issues. An updated version of the work plan is circulated with the minutes for endorsement in the next meeting.

4. YTF Update:

Youth Inter net Use Survey- YTF supported the Inter net Use Survey, conducted by a group of researchers from US universities in coordination with UNHCR. YTF gave feedback on the survey and facilitated visits to youth programmes in Za'atari during the visit 5-7 January 2015.

Higher Education in Emergencies Conference (Brussels) -Irene (UNHCR), Eddie (UNESCO) and Emma (NRC) presented their experience of the Higher Education in Emergencies conference in Brussels in December. Participants identified the strong need for HE among Syrian youth, but responses focused on out of country scholarships. The YTF members highlighted protection concerns and the need for HE responses to be coordinated with other programming and sectors. YTF members will follow up with stakeholders and potential partners in promoting field perspective issues in HE.

Desk research on Syrian youth- In YTF meeting on 30 December, Philmon (UNHCR) presented plans for a desk study initiative about the situation of Syrian youth in Jordan, including demographics, programme responses and identifying gaps/needs. The purpose of the study is to present data on youth accessibly, which could then be used for advocacy and planning
