Summary of discussions and action points

1. Dashboards (UNICEF)	<ul style="list-style-type: none">▪ Today (13/3/2015) is the final day to submit the February dashboards▪ Many changes were made in the dashboards such as the deadline/addition of population cohort▪ Sector leads to ensure that dashboards incorporate narratives, sectoral and cross-sectoral analysis▪ Flexibility was requested to make it more useful (suggestions for a trial period of 3 months)

	<ul style="list-style-type: none">▪ A monkey survey to be developed on all products to see how it is received by external audiences and how to better improve the dashboards▪ Discussions were made on deadlines/ skipping the validation process and relying on what was reported by partners▪ It was agreed to cut the validation process, stick to the current timeline, keep the population cohort bar.
2. Public institution support tracking (UNDP)	
	<ul style="list-style-type: none">▪ Need to track support provided to public institutions across the response▪ Support to public institutions a key part of the plan▪ Need to show to government counterparts how much support is provided to public institutions (repeated request during the LCRP steering committee)▪ Important leverage/advocacy element in case of restrictions of areas of operations▪ 124 activities and 131 indicators directly linked to support to public institutions at local and national level already in the system▪ Need to check that the existing indicators capture all the activities- Three options were highlighted and discussed▪ The importance of profiling was noted to track what actors contribute to public institutions in order to promote development.
3. Social Stability mainstreaming (UNDP)	
	<ul style="list-style-type: none">• The sector implements interventions aiming at reducing tensions by:<ul style="list-style-type: none">○ Facilitating interaction between communities○ Setting up conflict prevention mechanisms○ Supporting the role of local institutions in mitigating tensions.• Social Stability identified as one of the three priorities for the overall LCPR.• How can Social Stability sector support others in mitigating tensions<ul style="list-style-type: none">○ Overview of available tools – conflict map, participatory guidelines.○ Tool under development: tension assessment tool, a short questionnaire for partners to use in their M&E to assess their impact on tensions and social stability. Comments from sector leads welcome before the tool is finalized, translated, and an activity info database is set up for reporting.○ Discussion on what other tools will be needed. Inter-agency survey to come to identify gaps and needs from partners.○ Each social stability core group member to follow one particular sector to ensure liaising with them.



4.	Joint Analysis Unit (OCHA) <ul style="list-style-type: none">▪ The Joint Analysis Unit (JAU) is established in 2015 as part of the Lebanon Crisis Response Plan (LCRP) which is led/coordinated by the Office of the Resident Coordinator/Humanitarian Coordinator and the Government of Lebanon.▪ It provides analytical support to evidence-based programming and advocacy in-line with the needs and priorities of the Government of Lebanon, and the related requirements of development and humanitarian response actors▪ The JAU's main role is to provide support to the LCRP response partners at central and field level, and NGOs by conducting analysis of key humanitarian and stabilization issues

Intro to new CBPF guidelines <ul style="list-style-type: none">▪ Country Based Pooled Funds (CBPF) will continue allocating resources and saving lives at the time humanitarian needs emerge or escalate▪ CBPFs will remain as flexible tools in the hands of the humanitarian community at country level, and should translate into well-coordinated, relevant, transparent and accountable funding decisions▪ The overall process/allocation types were highlighted▪ Next steps:<ul style="list-style-type: none">○ To agree on dates for a GMS training; (24 April)○ To agree on the scorecards format; (a draft scorecards will be shared-

	<ul style="list-style-type: none"> ▪ OCHA: Kuwait 3 to take place at the end of March- importance of the conference was highlighted re-pledges to be made regionally for the Syrian crisis ▪ WFP update on the last IA held in Quobauyate concerning of no shows of 20% of beneficiaries for distribution and the potential implication on sectors and responsibility (it was noted that results were not yet final-to be discussed in the next IS meeting) ▪ IOM: HRC and IOM are planning a second round of registration for Lebanese returnees, now set to be conducted in April and May this year- an email was shared with IS group- inputs/feedback to be shared by COB Tuesday March 17. ▪ Fund tracking by sector to be done on a quarterly basis- (to be send to the heads of agencies) ▪ Discussions were made on coordinators meeting (biweekly basis) ▪ Cross sectoral matrixes to be shared with the IS group ▪ Suggestions to add CP/WFP validation as agenda item of the next IS meeting ▪ IA meeting to be held in April: on the 3rd Friday of the month followed by IS (4th Friday).
