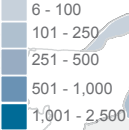

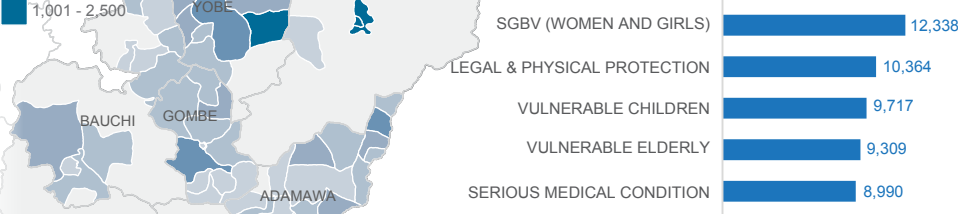

The highest proportion of vulnerable households in North East Nigeria comprised 32% HH in Yobe, 24% HH in Borno, 20% HH in Adamawa, 12% HH in Gombe, 7% HH in Bauchi and 6% HH in Taraba.



17,534 displaced households with severe protection risks and needs identified through protection monitoring. 450 referrals by UNHCR of women and girls in Adamawa to Nigerian Red Cross Society (NRCS) for psychosocial support. as tracking interventions to households to minimize gaps and overlap, pending agreement to information sharing protocols on confidentiality and data protection.

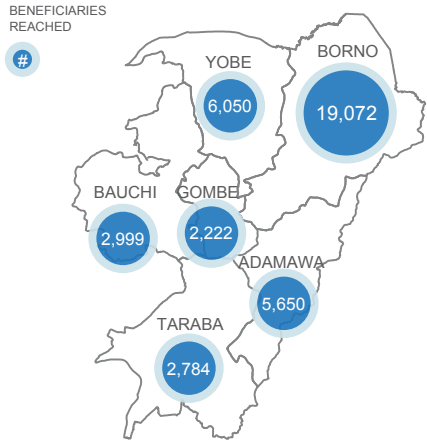

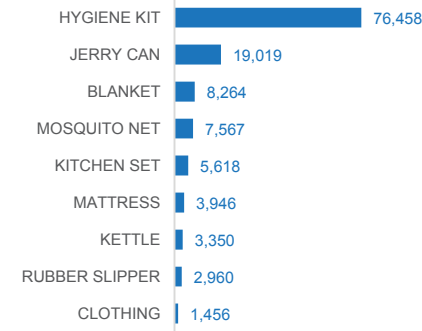

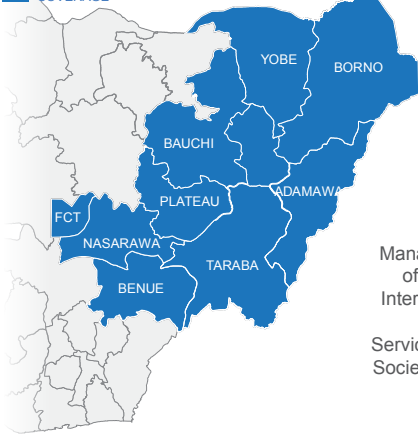
- Targeted advocacy by UNHCR led to formation of a House of Representatives Committee on IDPs, Refugees and NE Initiatives
- Task Team on Law and Policy by UNHCR for the Domestication of the Kampala Convention
- UNHCR advocacy on maintaining the security of IDP camps and Protection sensitive response to Cholera outbreak in IDP camps in Maiduguri
- Embarked on several courtesy visits to the National Institute of legislative Studies (NILS) and the Speaker of the House of Representatives to advocate for the a legal framework for IDP pro
- A draft Bill for IDP Protection sponsored by the Chairman of the IDP committee
- UNHCR-led PSWG advocacy in ensuring the compliance of return of Nigerians from neighbouring countries and IDPs occurs in a manner consistent with applicable international, regional and national standards
- PSWG position paper on durable solution for IDPs and Nigerian returnees adopted at the technical level and validated by the Humanitarian Country Team (HCT) in June 2015 and the PSWG subsequently released guidelines operationalizing the recommendations.

4,940 stakeholders reached through 44 trainings of which 281 stakeholders trained on Camp Coordination Camp Management (CCCM), 294 Military officers trained on Human Rights, and 40 Immigration officers trained on basic protection principles and registration, 2,890 reached through 11 community-based protection sensitizations

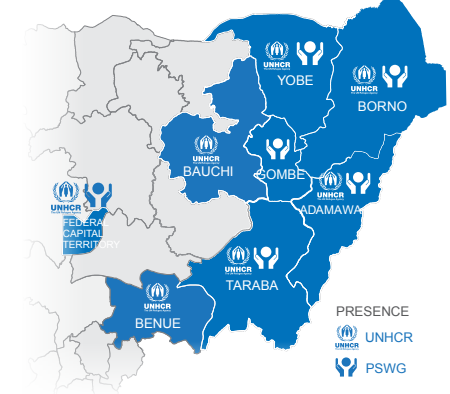
NIGERIANS FROM CAMEROON REGISTERED BY NIGERIA IMMIGRATION SERVICE FROM AUG - DEC 2015

UNHCR-LED STATE LEVEL PROTECTION SECTOR WORKING GROUP (PSWG) FORMED



- UNHCR coordination of PSWG at the National and state level scaled up; 5 UNHCR-led state-level PSWGs formed in 2015.
- UNHCR has scaled up its footprints in the North-East with the establishment of 5 field units
- UNHCR-led PSWG Visioning and Strategic Retreat held in August 2015, with resulting Conclusions, Recommendations and Follow-up Actions developed
- Bimonthly National and State level PSWG coordination meetings.
- Mapped and tracked partners' presence to record who is doing what where
- Provided technical support to the Ministry of Women's Affairs in all six states in establishing mechanisms in the prevention and response to SGBV
