## Contextual Background

### Historical background

- Pugnido 2 was opened on 25 August 2015. It was established to host South Sudanese refugees who arrived in Ethiopia during the second quarter of 2015 and were residing in transit centers at Matar, Burbiyey and Pagak entry points. The first relocation convoy from Matar was received on 25<sup>th</sup> of August 2015. Up to 15<sup>th</sup> of January 2016, 21 relocation convoy movements have taken place, bringing the total population to some **16,546** persons consisting of **4,004 households**

### Areas of Origin

- The camp population is composed of refugees mainly from South Sudan's Upper Nile (82.6%) and Jongolei State (16.4%), while smaller percentages came from other states.

### Ethnic composition

- The main ethnic groups are the Nuer, more than 98%

## Administrative Structure

- UNHCR** provides **Coordination Support, Protection, Registration, Logistics, and Technical Expertise** and monitors the delivery of services.
- Camp management and coordination, protection, registration, distribution of Food and Core Relief Items, Primary education, Health services and Security is conducted by Ethiopia's governmental body the **Administration for Refugee and Returnee Affairs (ARRA)**
- UN Agencies** (WFP) and **Partners** (IRC, ACF, PIE, DRC and IMC) are on ground and work together with ARRA and UNHCR in the provision of various essential services. Other partners expected on board in 2016
- Monthly Camp Coordination Meeting** is co-chaired by ARRA and UNHCR, on one of the working days between 1<sup>st</sup> - 7<sup>th</sup> of each month.
- Pugnido 2 camp is situated about 1 km to the north of Old Nuer Site. Its development is still in progress

## Operations and Services

- Core protection activities include detailed individual registration, documentation, training of **refugee community leaders**, **legal assistance**, **protection counseling**, **empowerment** of vulnerable groups and human rights monitoring. Capacity building and training of police and Woreda authorities on key subjects like Ethiopian refugee policy, child protection and refugee rights is yet to be strengthened.
- Refugees have access to legal counseling through UNHCR's partnership with ARRA protection teams. Refugees are assisted in bringing their cases to either the Police Station in Pugnido Town or the judicial court in Abobo.
- UNHCR and partners have community systems in place that allow for continued identification of Unaccompanied Minors and Separated Children and their placement in community-based foster care. There are 298 UAM and 2,457 SC identified and recorded.
- Refugee Central Committee (RCC) has been constituted and is composed of a chairperson, a deputy, secretary, treasurer and about 7-10 ordinary members. The RCC is the main link between the refugee community, ARRA, UNHCR and other implementing partners with regard to community mobilisation and implementation of activities in the refugee camp. ARRA has also put in place refugee Zonal leaders to work with RCCs.
- UNHCR provides and ARRA distributes Non-Food items to the refugees upon arrival. It also distributes food ration once a month that is provided by WFP. Food storage facility has been established. Refugees receive food at distribution centre which is adjacent to reception centre 2.
- At the moment, 1 emergency health care facility run by ARRA and one Nutrition centre operated by ACF is in operation. IRC has installed emergency water supply system and has completed drilling of two boreholes which are operational. ARRA and PLAN have commenced the setting up of ECCD and primary school learning centres.
