Lack of proper storage house.</li> <li>6. Moving of the burnt container.</li> </ol>	<p><b>1a HCDPC</b> is going to receive a donation.  <b>1b All members</b> will examine the possibility of the handing over of the tents of those who may depart to new arrivals.  <b>2a SP</b> in cooperation with the <b>RIS</b> will undertake this responsibility. <b>SP</b> can support after their budgets approval. (1 July 2016).  <b>2b.BRF</b> in cooperation with <b>UNHCR</b> are preparing a map planning of the RIC. NFI core relief items distribution on a daily basis to new arrivals by <b>SP</b> and <b>Samos Volunteers</b>. <b>All members</b> highlighted the importance of a distribution schedule to avoid duplication and overlapping.</li> <li>2. <b>All member</b> identified Gaps of certain NFIs provision.</li> </ol>	<b>1a.All members</b> to forward to <b>WG chair</b> their weekly distribution plan. <b>1b.WG chair</b> to prepare a distribution schedule on a weekly basis and update on a weekly basis. <b>2a All members</b> to prepare a report for NFI gaps and forward to <b>WG chair</b> . <b>2b All members</b> to send their stock reports to <b>BRF</b> . <b>2c.BRF</b> to update the stock of all agencies on a monthly basis.
