<p>Agency Updates</p>	<p>UNICEF-UNHCR: The child Marriage Task Force has been reactivated under the leadership of UNICEF and UNHCR. The first meeting of the Task Force took place on 4th April, 2017. The Task Force will remain active for a period of six months and the membership will remain open until the next meeting. At present the Task Force is focussing on mapping of interventions and programmes addressing child marriage issues in Jordan.</p> <p>Jordan Humanitarian Fund (OCHA): Altogether 16 proposal were submitted under the Jordan Humanitarian Fund. Four out of these were focused on addressing SGBV. The final decision about the appeal will be made in two-three week's time.</p> <p>UNFPA: The new interagency case-management guidelines for GBV (2017) have been finalized. The training materials will be developed soon and will be shared with the sector members.</p> <p>UNFPA developed a new training manual on '<i>Establishing Women and girls Safe Spaces</i>'. A facilitator and participant guide accompanies the manual. <p>Presentation on Clinical Management of Rape (CMR) Guidelines for Jordan</p>	<p>Dr. Manal Tahatmouni delivered a presentation on the new Clinical Management of Rape guidelines developed under the umbrella of the National Council for Family Affairs (NCFA) with the technical support of UNFPA and UNICEF. The guidelines are based on the best practices of developing CMR guidelines in the region. The previously developed tools and guidelines e.g Quality Assurance Standards for the provision of services to the survivor of domestic violence (NCFA), WHO guidelines of dealing with sexual violence cases, Family Protection Department (FPD) Protocols and IRC multimedia, package on Clinical Care of Sexual Assault Survivors (CCSAS) have been taken into consideration while developing these guidelines. The guidelines will introduce the case management approach to the health sector in Jordan. 	only the Ministry of Health (MoH) but the broader health sector which also includes civil society and private health care providers. All relevant forms that are reflected in the National Framework for Family Protection are unified under the new guidelines. The guidelines are endorsed by the National Protection team that consists of MoSD, MoH, IFH, JRF, etc and are presently awaiting final approval from the Prime Minister's Office.		
Presentation on Jordan Women Union Trends Report 2016	Jordan Women Union (JWU) is providing protection and GBV related services in 16 location of Jordan. From these locations, they are collecting data on GBV and analysing trends. The trend report for 2016 was shared with the sector members. Domestic violence was reported as the most significant type of violence reported by the survivors. Foreign nationalities (Bangladesh, Somalia) were the mainly among the survivors who received shelter related services. The sector members noted that the numbers reflected on child marriage are less than the numbers reported in the GBVIMS which is reflective of the high occurrence of child marriage among Syrian refugees compared to Jordanians. Activity Info Reporting	The reporting on SGBV indicators in the Activity Info is not up to date. The sector coordinator showed four SGBV related indicators and urged sector member to regularly report on the indicators (especially on the indicators on sensitization on core principles of GBV where the reporting is very weak) so as to meet the defined target.
