<b>Welcome &amp; Introductions</b>	<ul style="list-style-type: none"> <li>National CCCM/NFI/Shelter Cluster Coordinator (CC) chaired the meeting and welcomed participants.</li> <li>Self-introductions made before starting the meeting.</li> <li>CC said based on latest reports in terms of visa issues, it was unlikely that the new CCCM/NFI Coordinator Richard Warren would arrive in Yangon next week. 	<p>Following concerns about lack of winterization items in the camp; CC followed-up with TIKA in YGN. Confirmed that they did provide in December mosquito nets, garments and rain coats. What detail they had would be plugged into the NFI Tracking Sheet, found within the Cluster Analysis Reports available at: <a href="https://www.sheltercluster.org/Asia/Myanmar/RakhineAndKachin/Pages/Rakhine-DataAnalysis.aspx">https://www.sheltercluster.org/Asia/Myanmar/RakhineAndKachin/Pages/Rakhine-DataAnalysis.aspx</a>. In brief summary, mosquito nets – 5,000; garments (for men, women and children) – 25,000 pieces (10,000 longyis for men, 5,000 longyis for women and 10,000 (tops and shorts) for children); rain coats (for adults and children) – 15,000 (10,000 for adults and 5,000 for children). Caseload was described as “IDPs in camps though not official IDPs” and “some host families”. Not given on 50/50 basis.</p> <p>MAUK and AGE to supply details of recent or planned distributions.</p> <p>Noting NFI strategy in <i>2015 Humanitarian Response Plan</i>, determining vulnerability is a central issue. CC had consulted other responses, most recently Philippines. In Rakhine, noting the very similar conditions that most IDPs lived, HH characteristics would be one area to consider since housing conditions, access to services etc. were so similar. Fully recognised that determining vulnerability in such contexts as the camps would be challenging. b. Actions/Issues Arising of 5 <sup>th</sup> and 8 <sup>th</sup> December Meeting			
i.) Focal Point Coordination Meeting	CMAs (DRC, LWF, SCI and RI) agreed to organize focal point coordination meeting at Sittwe level once a month to raise key issues from the camps because some issues, including matters concerning CMCs, can't be raised at camp level coordination meetings. They need to be raised at the Sittwe Town level. Cluster Lead was supportive but some concern if this would generate too many/more meetings? Consensus was this was necessary. Sample hard copies were shared today. The four key CMAs each got a full-set of the 23 priority camps.</p> <p><b>Word</b> documents, produced by previous CCCM/NFI Cluster Coordinator were to be called “factsheets” but a new name would be needed if the DRC document were to materialise. Hard copies had been shared with CMAs and OCHA noted the value of these documents. Likely though they would be updated once, perhaps twice a year.</p> <p><b>Camp 3Ws</b> are also available, and have been circulated at the national level. c. NRC Myanmar CM/CCCM Training Unit	<p>NRC’s Veit Vogel (<a href="mailto:veit.vogel@nrc.no">veit.vogel@nrc.no</a>), tel. 09 2522 26082 was introduced. Strong background in CCCM, key author of the <i>Tool Kit</i> and was here as part of NRC’s increasing efforts to support the CCCM Cluster. Intention was he would be Rakhine based. Strong training credentials. NRC soon to circulate document outlining some of the support it can offer.</p> <p>Noting the minutes from the last meeting, 5 December, two references to training needs:</p> <ol style="list-style-type: none"> <li>CCCM role and responsibility training for service providers – proposed by LWF-DRC-RI</li> <li>IOM was to see what support it could offer RI capacity needs.</li> </ol> <p>It had also been stressed that general awareness and understanding of “what is CCCM” at Head of Office level in Rakhine could do with support. <p>Issues – All partners</p> <p><b>DRC</b></p> <p><b>SCI</b></p> <p><b>LWF</b></p> <p><b>RI</b></p> <p><b>UNICEF</b></p>	<p>Noted that the government is constructing “some kind of building for cyclones”. Staff will find out when they go to field. DRC also raised the issue of health in the camps, citing the mortality matrix.</p> <p>Mentioned the issue between CMCs of Set Yoe Kya-1 &amp; Set Yoe Kya-2, which concerns imbalance of staff in the camps by the service providers. Relating to these issues, IRC was not allowed to construct a women’s centre in the camp.</p> <p>Planning to meet/advocate with District Commissioner to restructure CMCs due to major concerns over host community influence. Also suggested to conduct pond mitigation awareness raising campaign/training to try and reduce the likelihood of accidents. On the wider issue of CMCs, CC stressed this had to be a central focus of the Cluster’s work in 2015. To quote the last sentence verbatim from the CCCM section of the HRP: <i>“A vital objective for this Cluster is to support the Government’s leadership, particularly with regards to camp administration and the selection and role of camp management committees, including setting up and support to women’s committees.”</i><sup>1</sup> CC noted this was also an area that he had discussed with NRC as something they may wish to lend their expertise/support.</p> <p>No update.</p> <p>Like DRC, they have some information that the government plans to construct cyclone shelters in the camps but they are not sure if this building is specifically for IDPs?</p>	<p>DRC will update.</p> <p>LWF will update</p> <p>UNICEF &amp; DRC will update.</p>	<p>By next meeting</p> <p>By next meeting</p> <p>By next meeting</p>
<p><b>e. AOB</b></p>	<p><b><u>Pond Mitigation</u></b></p> <p>Views were expressed:</p> <ul style="list-style-type: none"> <li>In Pauktaw camps <b>LWF</b> had discussed water sources and fencing ponds to avoid reach of children and animals. In that situation Solidarities International agreed to fence the pond area(s).</li> <li><b>UNICEF</b> noted that some ponds were built by landowners before camps were established. They could be removed but consent would be needed. Stressed that they should be addressed on a case-by-case basis.</li> <li><b>DRC</b> noted the assessment as discussed at the last meeting.</li> </ul> <p>Conclusions were that if a particular pond was noted as a serious health and safety issue, bring it to the attention of Cluster Lead. 	<p><b><u>GENCAP</u></b> CC noted two documents shared: <i>CCCM Commitments to Gender Equality</i> and (as an example) <i>Gender Mainstreaming Checklist for Camp Managers in South Sudan</i>. GENCAP's key priority is establishing GenCap focal points, two per Cluster/sector per location, YGN, Rakhine and Kachin. CC was not convinced there would be the appetite for so many, with a possible compromise of one per Cluster/sector per location. GENCAP was also suggesting two-day w/shop for these focal points. Thus far only LWF, at the national level, had suggested some modest interest in being a focal point. More generally and following WaSH's comments, CC fully agreed with efforts to have gender assessments/evaluations of Cluster's activities.</p> <p><b><u>HEALTH</u></b> Since last meeting CC noted there had been considerable exchanges around health issues and particularly mortality reporting from the camps. Central themes emerging:</p> <ol style="list-style-type: none"> <li>1. Should CMAs report on health issues, particularly mortality?</li> <li>2. If so, in what format and to whom?</li> <li>3. Assuming correct reporting was done, what recourse or pathways were there to address concerns as they emerged?</li> <li>4. Immediate tangible examples being clinics in the camps having no antibiotics or closed when they say they should be open. To whom should they report and what action might be taken?</li> </ol> <p>Immediate Actions:</p> <ul style="list-style-type: none"> <li>✓ On the matter of reporting, to avoid mass communications on these technical areas, WaSH Cluster was developing SOPs. CC welcomed these and looked forward to them being operationalized so CMAs know to whom and what they should report.</li> <li>✓ Following, mortality matrix developed by this Cluster should be discussed with Health Cluster before being put into action.</li> <li>✓ CC to follow-up with national health counterpart, articulate concerns in writing and report back at next meeting, which includes mortality matrix.</li> </ul> <p>CC stressed that moving things forward in this area would not be easy and would take time.
