**1. DEMOGRAPHIC AND SOCIAL PROFILE**


**Summary**

Baba Wali Sahib, in Arghandab District, is an IDP-returnee village surrounded by Langer, New Mazara, Jabadar and Jilaran. Both Arghandab District as a whole as well as Baba Wali Sahib and its surrounding villages have experienced intensive military operations over the past two decades. Recent displacement, particularly from Baba Wali Sahib, occurred during military clean-up operations.

Of the 432 households surveyed in Baba Wali Sahib, 279 (65%) were returnee households, 136 (31%) were local community households and 17 (4%) were IDP households. The households encompass a combined total of 3,628 individuals with a gender ratio of 1.1 males for each female.

The average household size was revealed by the survey to be 9.1 persons among the local community, 8.5 persons among IDPs and 8.0 persons among returnees. Children (0-17 years) represent over half the average household size among local community and returnee households and almost two-thirds of IDP household members, with approximately 1.1 boys for every girl.

The elderly (aged 60+) were found to constitute 3%-5% of the population across all three household types. Approximately 2% of the population reported to be widowed with eight times as many widows as widowers.




**2. MIGRATION PROFILE**

**Summary**

Among the households surveyed, the year 1387 (2008/09) witnessed the largest number of returnee arrivals in HRA with 53 returnee households choosing to settle in Baba Wali. Also, the year 1391 (2012/13) witnessed the largest number of IDP arrivals with 3 IDP households choosing to settle in HRA. Prior to 1387 (2008/09), on average, approximately 35 returnee households per year have chosen to settle in the area. Prior to 1391 (2012/13), an average 2 IDP households per year have chosen to settle in Baba Wali.




Of returnee and IDP households that have settled in Afghanistan in the last two years, 92.3% of returnee and all of IDP households stated that they did so voluntarily. Of these, 92.3% of returnee and 80.0% of IDP households stated that they intend to remain in the area.

All returnee households had sought asylum in either Pakistan (94.0%) or Iran (4.2%) with 93.2% stating that they did so for safety due to conflict. Over four-fifths also cited economic reasons and three-quarters cited harassment/discrimination. A further, 10.0% of returnee households stated that they sought asylum due to family reasons.





Among IDP households, over four-fifths cited economic reasons and over three-quarters stated safety reasons due to conflict as the main reasons for having fled their districts of origin. Over two-thirds also cited harassment/discrimination reasons as having influenced their decision to move. A further, over one-third stated that they have fled their districts of origin because of family reasons.

Four-fifths of households stated that economic reasons and three-fifths cited legal difficulties were the main reasons of returning back to Afghanistan. Further, over two-quarters stated place of origin as having influenced their decision to return. A further over one-fifth of households returned to Afghanistan because of safety reasons.





**3. HOUSING STATUS PROFILE**





Survey findings reveal that 60% of both local community and returnee households and 47% of IDP households currently occupy single family homes. The majority of remaining households across all three groups were found to be residing in part of a shared house. A further 10% of returnee households and 6% of IDP households occupy a tent, and 6% of IDP households and 1% of returnee households were found to be residing in a temporary shelter or shack. With the exception of tents, almost all dwellings across all three household types were mud-brick or mud constructions. Brick was reported to be the main construction material of the roofs of 88% of local community dwellings, 78% of returnee dwellings and 71% of IDP dwellings.

The majority of local community households were found to be residing in three-room dwellings (27%), four-room dwellings (26%) and two-room dwellings (21%). Returnee households were similarly found to be residing in two-room dwellings (35%), three-room dwellings (26%) and four-room dwellings (18%). The majority of IDP households occupy two-room dwellings (47%) and three-room dwellings (24%). Approximately 17% of local community households, 16% of returnee households and 12% of IDP households reside in dwellings featuring five rooms or more.

With regard to cooking facilities, 72% of local community households, 47% of returnee households and 41% of IDP households have a separate kitchen. The majority of remaining returnee households (47%), IDP households (47%) and local community households (20%) cook in the open.

**4. WATER, ELECTRICITY, FUEL AND SANITATION**

**Summary**

**Water:** Hand pump is the main source of water for (40%-45%) of all three household types. It is located on average 5 minutes away from local community households, 8 minutes away from returnee households and 12 minutes away from IDP households. A further, 22.1% of local community households, 28.3% of returnee households and 35.3% of IDP households have access to open body of water which is located on average 17 minutes away from local community households, 16 minutes away from returnee households and 23 minutes away from IDP households. The remaining households use open well and bored wells for their water source.

**Electricity:** Of the 432 households surveyed, a total of 344 (79.6%) reported to have had access to an electricity supply in the 30 days prior to being surveyed. Electric grid was the most important source of electricity for 95.1% of local community households, 90.6% of returnee households and three-quarters of IDP households. Proportionally IDP households (12.5%) have more access to solar power than local community (4.1%) and returnee households (2.8%). Small percentages of households have access to government generators among all three household types. Moreover, only 5.2% of returnee households have access to battery.






**Fuel:** During the winter months, bushes, twigs/branches and straw was the most important source of heating for 71.3% of local community households, 64.2% of returnee households and 64.7% of IDP households. A further, 10.3% of local community, 14.3% of returnee and 11.8% of IDP households use firewood for heating. Moreover, 5.9% of local community, 8.6% of returnee and 11.8% of IDP households use animal dung for heating. Proportionally, more IDP households (11.8%) have no heating during winter compared to local community households (8.1%) and returnee households (7.2%).

Bushes, twigs/branches and straw provide cooking fuel for 47.1% of local community, 38.7% of returnee and 41.2% of IDP households. Proportionally, returnee households (34.4%) use more gas for cooking than both local community households (17.6%) and IDP households (17.6%). On the other hand, local community households (29.4%) use more firewood than returnee households (19.4%) and IDP households (17.6%). 11.8% of IDP households use animal dung for cooking which is greater than 3.7% of local community and 5.7% of returnee households.





**Sanitation:** 71.3% of local community and 64.7% of both returnee households and IDP households use traditional covered latrine. A further, 22.1% of local community households, 28.8% of returnee households and 35.3% of IDP use open pit latrines. Moreover, 2.9% of both local community households and returnee households use open field, bushes, and sahrahi for toilet. Similarly, 2.2% of local community and 2.9% of returnee households use dearan (not pit).

Surveyors took note of whether any garbage or pools of stagnant water were observed in close proximity to the households they interviewed. 33.8% of local community households, 25.5% of returnee households and 52.9% of IDP households didn't have any garbage near their dwellings. A further, 58.6% of local community households, 65.5% of returnee households and 35.3% of IDP households had little garbage near their dwellings. Furthermore, 9.6% of local community households, 9.0% of returnee households and 11.8% of IDP households had a lot of garbage near their dwelling. Also, 84.6% of the local community, 75.5% of returnee households and 94.1% of IDP households didn't have any stagnant water near their dwellings. In addition, 9.4% of local community households, 23.4% of returnee households and 5.9% of IDP households had little stagnant water near their dwellings. Moreover, less than 2% of both local community and returnee households had a lot of stagnant water near their dwellings.


**5. LABOUR & LIVELIHOODS**

**Summary**


According to survey findings, 27.5% of local community members, 25.7% of returnees and 20.8% of IDPs are engaged in work for the family. Of those working for the family, 93.3% of IDPs, 83.7% of returnees and 73.0% of local community members are female. A further 21.0% of returnees, 20.1% of IDPs and 17.7% of local community members reported to be working for a salary of which over 90% in all groups are male. Industry represents the main employment sector for 72.4% of IDPs, 63.5% of returnees and 57.3% of local community members. Marginally more returnees (17.7%) work in the service sector compared with local community (15.1%) and IDP (13.8%) counterparts. Similarly, IDPs (13.8%) were more likely to be working in agriculture than local community members (10.6%) and returnees (9.6%). More local community members (15.1%) reported to be working in the government sector compared with returnees (8.3%) and IDPs (0.0%).

Among those aged 12-17 years, 47 returnees, 23 local community members and seven IDPs were reported to be working. One local community member aged 5-11 years was also reported to be in work.


**5.1 Percentage of household members working**




**Summary**

**Income:** Average household income in 1390 was USD 3,037 among local community households, USD 2,386 among returnee households and USD 2,253 among IDP households. Wage labour was the main source of income for 64.7% of IDP households, 60.6% of returnee households and 44.9% of local community households. Remaining local community and returnee households derived annual income from agriculture, government services or trade, in varying proportions. Remaining IDP households derived income from either agriculture (17.6%) or day labour (11.8%).







Average household debt was revealed to be USD 2,296 among local community households, USD 2,247 among returnee households and USD 1,404 among IDP households.

**Expenditure:** Average household expenditure in the month prior to being surveyed was USD 228 among local community households, USD 184 among returnee households and USD 131 among IDP households. IDP households (71.0%) spent a larger proportion of monthly expenditure on food supplies than returnee (64.1%) and local community (61.8%) households.

**Assets:** With regard to ownership of key household assets, in the region of three-fifths of all households own a stove/gas balloon and a radio. Over four-fifths of all households also own a mobile telephone. Comparable proportions (35.0%-45.0%) in all households own a bicycle. IDP households (76.5%) were significantly more likely to own a motorcycle than local community (61.0%) and returnee (50.5%) households. Similarly, local community households (12.5%) were marginally more likely to own a car than returnee households (11.1%), and significantly more likely than IDP households (5.9%).







**Summary**

**Agriculture:** Of surveyed households, only 17.6% of local community households, 12.5% of returnee households and 5.9% of IDP households have access to agricultural land. In 1391, on average, 9.7 jeribs of land were cultivated by local community households, 4.9 jeribs by returnee households and 2.0 by the sole IDP household with access to agriculture land. Wheat was the most important crop for the IDP household, 52.9% of returnee households and 39.1% of local community households. Tomato was the most important crop for a further 21.7% of local community households and 11.8% of returnee households. A garden plot is accessible to 27.2% of local community households, 12.9% of returnee households and 5.9% of IDP households.







**Livestock:** Some form of livestock is owned by 76.5% of IDP households, 64.7% of local community households and 59.9% of returnee households. Among households that do, over three-fifths in all three groups own chickens. Approximately three-fifths of local community and IDP households own sheep compared with two-fifths of returnee households. One-third or more in all household types own cows. Goats are owned by proportionally more returnee households (35.3%) than IDP (30.8%) and local community (15.9%) households.












**8.1 Average time taken to walk one way to Province Centre**



**8.2 Average number of times a HH member has travelled to Province Centre in last three months**




**8.3 Main reasons for travelling to Province Centre in last three months**




**8.4 Average number of times a HH member has travelled outside Province Centre in last three months**





**9. EDUCATION PROFILE**

**Summary**

Among those aged five years and over, 25.9% of the local community, 20.3% of returnees and 9.8% of IDPs reported to be literate. Of these, 42.9% of local community males, 32.4% of returnee males and 17.7% of IDP males reported to be literate. Similarly, 7.0% of local community females and 7.1% of returnee females reported to be literate.

Among adults aged eighteen years and over, 93.8% of local community males, 93.4% of returnee males and 96.4% of IDP males did not achieve any school grade. Similarly, approximately all females across all three households had not achieved any school grade.

Among males aged 6 to 24 years, 46.6% of local community males, 40.6% of returnee males and 14.3% of IDPs males reported to be currently attending school. Among females aged 6 to 24 years, 6.5% of local community females and 9.8% of returnee females reported to be currently attending school. The main reason for not attending school given by those aged 6 to 24 years across all three groups was because there is no school or it is too far. Proportionally less IDP members (11.8%) of those aged 6 to 24 years didn't attend school because there is no female teacher compared to returnee (22.8%) and local community (20.0%). A further, 16.5% of those aged 6 to 24 years across all three groups didn't attend school because they needed to work to help family.



**9.3 Age distribution of literate household members**




**9.11 Age distribution of males who received education in another province**






**Summary**

71.3% of local community households, 21.1% of returnee households and 17.6% of IDP households had between one and two household members admitted to a health facility as an inpatient over the course of the previous month. 75.7% of local community, 66.7% of returnee and 58.8% of IDP households also had at least one member receive care from a health provider, a pharmacy or traditional healer without having to stay overnight. The private health facility was visited most by all three household groups, followed by the Regional Hospital. The most common reasons for seeking medical treatment by local community households were infectious problems (30.2%), digestive problems (18.3%), respiratory problems (11.2%) and psychological problems (10.1%). Similarly, for returnee households the most common reasons were infectious diseases (27.6%), digestive problems (20.4%), and treatment of respiratory problems (17.2%). Among IDP households, the main reasons for seeking medical treatment were infectious diseases (30.8%), pregnancy problems (23.1%), and treatment of digestive problems (15.4%).


Of the 799 females aged 13-49 years that were included in the survey, a total of 133 were reported to be married among local community households (n=65), returnee households (n=61) and IDP households (n=7). Based on this data, the average number of births stands at 5.5 for local community females, 4.8 for returnee females and 5.9 for IDP females. Correspondingly, the average number of infant/child deaths is 1.1 for local community females, 1.2 for returnee females and 2.0 for IDP females. Of the 131 females aged 13-49 years that have given birth, 60.0% of local community females, 71.2% of returnee and 71.4% of IDP females received antenatal care during their last pregnancy with an average of 3.95 antenatal care visits per mother, and 25.8% had the assistance of a midwife during delivery.

With regard to children under the age of five, 44.9% of local community children, 42.2% of returnee children and 40.0% of IDP children have been registered with the civil authorities. Over the course of the previous month, all of local community under-fives, 94.5% of returnee under-fives and 90.0% of IDP under-fives have received a Vitamin A capsule, and 44.1% of local community, 51.4% of returnee children and 30.0% of IDP children have suffered from diarrhea. Furthermore, 54.2% of local community children, 61.5% of returnee and 30.0% of IDP children have a persistent cough.

**10.1.1 Number of HH members admitted to stay at a health facility overnight in previous month**




**10.1.2 Average number of HH members admitted to stay at a health facility overnight in previous month**




**10.1.3 Percentage of HHs with at least one member who sought treatment from a health provider, a pharmacy or traditional healer without staying overnight**






**Summary**

Among local community households, three-quarters (75.0%) were affected by reduced drinking water. A further, 85.3% of local community households were affected by unusually high increase in food prices, 46.3% by reduced drinking water quality, over one-third (35.3%) by severe winter conditions and 31.6% of local community were affected by heavy rains preventing work. 85.3% of local community households responded to shocks faced by decreasing expenditures. A further, over three-fifths (63.2%) of local community households received help from others in the community, approximately two-thirds reduced quality and quantity of diet, and over one-quarter (29.4%) purchased food on credit from traders.


Among returnee households, 88.5% were affected by reduced drinking water. A further, four-fifths (79.6%) of returnee households were affected by unusually high increase in food prices, 56.6% by reduced drinking water quality, over two-fifths (41.2%) by severe winter conditions and 21.1% of returnee were affected by heavy rains preventing work. 81.4% of returnee households responded to shocks faced by decreasing expenditures. A further, over three-fifths (64.2%) of returnee households received help from others in the community, approximately two-fifths reduced quality and quantity of diet, and over one-third (35.8%) purchased food on credit from traders.

Among IDP households, 70.6% were affected by reduced drinking water. A further, 76.5% of IDP households were affected by unusually high increase in food prices, 29.4% by reduced drinking water quality, three-fifths (58.8%) by severe winter conditions and 41.2% of IDP were affected by heavy rains preventing work. 94.1% of IDP households responded to shocks faced by decreasing expenditures. A further, over three-fifths (64.7%) of IDP households received help from others in the community, 70.6% reduced quality of diet and 47.1% reduced quantity of diet, and 17.6% purchased food on credit from traders.

**11.1 General household shocks in 1390**




**11.2 Specific household shocks in 1390**



**12. PROTECTION PROFILE**

**Summary**

Of the 429 households surveyed, 84.0% had an adult male aged 18-59 years as head of household. The head of household of four local community households and three returnee households were a male aged 12-17 years. Moreover, 28 local community and 34 returnee households have an adult female aged 18-59 years as head of household. A total of 61 households had an elderly (aged 60+) head of household of whom 18.0% were female. Seven local community households and 15 returnee households were headed by a widow or widower.

Two local community male and one female, seven returnee males and five females aged 13-17 years was reported to be married. Among married adults, a total of 45 local community females, 43 returnee and five IDP females reported to have been under-18 years of age at the time of marriage.


Five of local community households, three returnee households and two IDP households contained more than one wife.

The survey found 117 people living with a disability of which 64.1% were male. The most common disabilities were reported to be either physical (29.9%) or sensory (19.7%) in nature. 52.7% of disabled local community, 48.7% of disabled returnees and 80.0% of disabled IDPs were adults aged 18-59 years. 13.9% of disabled people in local community households, 30.3% of disabled people in returnee households and 20.0% of disabled people in IDP households were aged 60 years and over.


Of the 650 females aged 6-17 years, all of IDP females, 90.2% of local community females and 86.6% of returnee females are currently not attending school.


**12.1.1 Age distribution of male heads of household**



**12.1.2 Age distribution of female heads of household**




**12.1.3 Age distribution of widowed heads of household**




**12.2 Marital Status**




**12.2.3 Marrying age of married adult women who were under-age at time of marriage**





**13. Child Labour**


**Summary**

Among households surveyed, a total of 78 children were reported to be working and include 1 children aged 5-11 years and 23 children aged 12-17 years among local community households, 47 children aged 12-17 years among returnee families, and 7 children aged 12-17 years among IDP families.

Child workers belonging to local community households were reported to be working on average of 8.4 hours per day with 62.5% of them were reported to be day labourer and 33.3% were self-employed. Child workers belonging to returnee households were reported to be working an average of 8.1 hours per day with 51.1% of returnee child workers reported to be day labourers and 38.3% were self-employed. Child workers of IDP families work an average of 8.6 hours per day and 85.7% were reported to be day labourers and 14.3% were self-employed.

Vast majority of children of all three household types were engaged in industry sector. The second most common sector for child workers among all three household types is agriculture sector.

**13.2 Distribution of male child workers by age and sector**



**13.3 Distribution of female child workers by age and sector**




13.4 Average number of hours worked daily by male and female child workers




13.5 Average number of hours worked daily by child workers by economic sector



13.6 Average number of hours worked daily by child workers aged 12-17 years by economic sector




13.7 Average number of hours worked daily by child workers aged 5-11 years by economic sector





**14. SAFETY AND SECURITY**

**Summary**

The security situation in the district was described as “moderately secure” by 81.6% of local community households, 78.9% of returnee households and 70.6% of IDP households. IDP households (29.4%) were significantly more likely to describe the district as “not secure, not insecure” than both returnee households (19.7%) and local community households (17.6%). Only returnee households (0.7%) described the district as “moderately insecure.”


With regard to safety, 47.3% of returnee households, 46.3% of local community households and 35.3% of IDP households “rarely” fear for their personal safety and security or that of their family. A further 46.2% of returnee households, 41.9% of local community households and 41.2% of IDP households “sometimes” fear for their safety. Proportionally more IDP households (23.5%) reported “never” fearing for their safety compared with local community (10.3%) and returnee (5.7%) counterparts. Small proportions of both local community (1.5%) and returnee (0.7%) households reported “mostly” fearing for their safety.

On the subject of policing in the district, 61.6% of returnee households, 58.8% of local community households and 52.9% of IDP households are “moderately satisfied” with the police. A further 41.2% of IDP households, 35.3% of local community households and 33.3% of returnee households reported to be “not satisfied, not dissatisfied” with the police. IDP households (5.9%) were also marginally more likely to be “moderately dissatisfied” with the police than local community (4.4%) and returnee (4.3%) counterparts.


Of the 432 households surveyed, 83 (29.7%) of returnee households, 47 (34.6%) of local community households and eight (47.1%) of IDP households had experienced some form of violence in the three months prior to being surveyed.
