Msf, IFRC, Praksis and Babel participated in the meeting. The GS announced that a new regulation will be published regarding AMKA in order to solve the current challenges.

 Society of Social Psychiatry and Mental Health: In the context of an agreement partnership with IRC, the Society of Social Psychiatry and Mental Health (SSP&MH) provides services in a hostel and an after school Day Center for Children (JRS-Arrupe) and a Community Center (Velos), under the model of the mixed mobile service:

Discussion with representatives of OKANA, KETHEA and 18ANO

- 18ANO: conducts support groups for migrants. An individual can participate in the support groups and later be engaged in total rehabilitation programmes. Interpretation is a challenge, since professionals speak only English and French language and no interpreters are available.
- KETHEA MOSAIC: provides support to migrant and refugee drug addicts to help them on the path to recovery and social integration, as well as support to their families and partners. It works in close collaboration with METAdrasi regarding the interpretation; therefore language is not an obstacle in the provision of services. A mobile unit of KETHEA provides services in the sites of Malakasa, Ritsona, Thiva and Thermopiles since December in collaboration with IOM and the MoMP.
- OKANA: Reception Centres of OKANA don't provide any kind of interpretation that is the reason why refugees are not referred there. However, OKANA is willing to cooperate with NGOs in order to be able to provide treatment with pharmaceutical substitutes in refugees.
- The three organizations expressed their willingness to collaborate with the present NGOs regarding the issue of individuals with dual diagnosis and the increase of substance abuse. Capacity building among the actors is also to be discussed. Therefore, it was decided to be created a taskforce that will work on these issues.
