		<ul style="list-style-type: none"> <li>- CP response: since November 2017 there has been no reporting on CP activities</li> <li>- Oromia CP/GBV response plan: anyone with planned or current activities in Oromia encouraged to participate in sub-cluster meeting to ensure reflection of activities</li> <li>- DTM round 8 (Displacement Tracking Matrix) currently under revision. Suggestions for revisions on protection indicators were circulated and discussed</li> </ul> <p><b>GBV</b></p> <ul style="list-style-type: none"> <li>- GBV sub-cluster actively participated in the 2018 HRD and Pillar framework at the HRD editing meetings Chaired by the NDRMC on behalf of the Ethiopian Government and Co-Chaired by OCHA. A total of US \$ 8.4 m has been required from GBV portfolio.</li> <li>- UNFPA is progressing in providing responses. Recently, 6,600 dignity kits have been distributed in Somali Siti Zone and 1,300 dignity kits have been distributed in Gambella</li> <li>- UNFPA supported by Demark funding is launching a new programme on Reproductive Health focusing</li> </ul>	<p>A protection cluster ad- hoc meeting will be held on Tuesday January 30 to review and agree on DTM indicators</p>

IDP Update	<p>on family planning in partnership with WFP in Somali region</p> <p><b>OCHA</b></p> <ul style="list-style-type: none"> <li>- Over 1 million displaced people, with highest number of displacement over the last 2 years</li> <li>- 90% of IDP sites are accessible, mapping continues but only a few sites are inaccessible</li> <li>- Access to Dawa solved and bridge over Dawa river has been completed and is usable for light trucks</li> <li>- Resettlement plan for Oromia including 11 sites almost completed with housing, schools, latrines and IDPs are expected to arrive by the end of this month</li> <li>- Food supplies to Jijiga is fine and no movement of supplies is restricted</li> </ul> <p><b>Protection cluster</b></p> <ul style="list-style-type: none"> <li>- A mission to Moyale to assess protection issues will be organized tentatively for the week of 19<sup>th</sup> February</li> </ul>	Protection cluster to send invitation to discuss mission details
