1. Review of last meeting's action points (31 July)	- The last meeting minutes were endorsed and placed on UNHCR's portal (Greece): https://data2.unhcr.org/en/documents/download/65687	N/A	
2. Update on the protection situation in the islands and mainland	 Islands Regional authority announced a decision that the conditions in Moria are substandard and they invite the MoMP to improve conditions, otherwise the RIC in Moria should close down within 30 days if the conditions are not addressed. Overcrowding beyond previous levels. Lesvos: approx. 10,000. Chios: approx. 2,500. Samos approx. 4,000. Leros approx. 1000. Kos approx. 1500. Mainland transfers slow (to sites), slightly higher in August than previous months (approx. 800). 700 transfers to mainland sites planned for this week. 680 transfers from Lesvos planned for this week, mainly to Skaramangas, Lesvos prioritised. Evros arrivals: approx. 700 in August. Registered then released. Matching of places prioritised to fill all bed spaces available. RIS: call for interpreter services is open. Constraints in the recruitment of cultural mediators and other staff during KEELPNO PHILOS I has led to gaps in the provision of services in the RICs and the public hospitals; KEELPNO was awarded the project for the continuation of medical services on the islands and the mainland, both in RICs/sites and public hospitals with an announced number of 1,576 staff. 	2019. Recognised refugees and integration: gap in planning and exit/transition strategy. More
	than 4800 recognised refugees live in ESTIA accommodation currently, there needs to be policy

- Interpretation challenges, such as the current lack of interpreters in public institutions, like hospitals, were raised during various forums including the health WG. Plans to discuss at intersectoral level.

Child Protection

Statistics on refugee and asylum seeking children in Greece were presented (June 2018):

- Total population PoC children in Greece is 23,000. 55% boys, 45% girls; 0-5years 43%; 6-12 years 36%; 3-17 years 21%;
- Syria 46%; Iraq 24%; Afghanistan 18%
- 766 monthly sea and land border (Evros) arrivals (children)
- 3,320 UASC in Greece: 95,9% boys, 4,1% girls 5,2 < 14 years (Ekka statistics)
- Children (including UASC) accommodated per different locations i.e. RICs, UNHCR accommodation scheme, safe zones, open sites, IOM hotels and SIL: 48% UNHCR accommodation, open reception and accommodation facilities 28 %, reception centers 16%, others 5%
- 439 UAC transferred from the islands to IOM facilities in the mainland & since January to 15 July,
 IOM ERAcUMIc project provided safe accommodation to 813 unaccompanied migrant children while the total accommodation capacity was 565 places, in a total of 12 hotels all over Greece

From January to July 2018, Asylum Service data:

- 1917 asylum applications for children population and UAC, 1235 boys, 782 girls
- 509 recognised refugee children and UAC, refugee status & subsidiary protection

Since June 2013 to July 2018, Asylum Service data:

- 11,500 applications (14% UAC) of Dublin/family reunification cases for children

SGBV

- Through a relevant decision taken by the Lesvos Municipality Board, the Mytilene safe shelter for women survivors of SGBV is no longer receiving referrals for refugee women (except in extremely urgent cases and only for up to 2 days- upon assessment) / reason given was lack of resources, but also to promote de-congestion of the island.
- SGBV WG Is continuously working on mapping the gaps/challenges in SGBV provision in open accommodation sites as well as with regard to security response to SGBV.

Prevention from Sexual Exploitation and Abuse SOP and reporting procedures	 Trend Analysis currently being conducted on SGBV incidents reported to UNHCR (identification and/or referrals), with a 40% spike in comparison to 2nd semester of 2017. Possibly linked to reduction of services and overcrowding. Other major challenges include lack of legal assistance and access to safe accommodation.
