None of the WASH partners have submitted their RRRP requirements in the system. One partner reported issues with the registration login process. UNHCR offered to provide a training with their support team to assist partners in submitting their data on the online system. One person from each organization should be delegated to input the data. The group suggested having a representative from Addis and a representative from the field office participate in the training. UNHCR will share the narrative of the RRRP with the partners for comments prior to finalizing the description for the report.
