Funding Required

Although the financial tracking system (FTS) denotes that the Sector has been provided with 0 % of funding towards its target of 105.4 million, this does not reflect the full funding picture for Protection operations in 2018. Many Protection interventions have been funded thus far through internal agency sources, including unearmarked contributions, that are not included in the tracking system. Any such sources of funding will be reflected at years end within the financial tracking

NIGERIA: PROTECTION OVERVIEW





Achievements: The February 23 Presidential and National Assembly elections were conducted in the three main affected states (Borno, Adamawa and Yobe), with minimal disruption to protection response. IDPs with permanent voter cards were allowed to exercise their civil rights in polling Units established by the INEC in the three States. Field presence was slightly reduced in some locations during the election period with no significant impact on protection delivery. Protection monitoring, grounded on local teams, remained functional throughout the election period. Protection risk profiling reached 27,183 new arrivals. Campaigns to raise awareness on human rights, accountability and feedback mechanisms benefited 21,409 individuals in the three States; a 10 per cent drop from 23,650 individuals in January. 717 individual received legal documentation and 539 received protection-based material assistance. The Sector remained engaged on the 90 Day Plan, focusing on protection mainstreaming and risk mitigation in the development of Mohammed Goni International Stadium site. The Sector finalized the beneficiary selection criteria for the relocation of new arrivals from Teachers Village camp. The blended criteria; "new arrivals, by community, each community include 30% vulnerable HHs" was welcomed by the IDP community.

The Housing Land and Property (HLP) Sub-Sector supported 365 IDP Returnees in Damboa LGA with the replacement of their land title documentation. In Yola, the Sub-Sector organized a two-day workshop for 31 stakeholders. The Sub-sector has requested shelter kits from the CCCM/Shelter Sector for the relocation of the IDPs residing in the Bale Galtimari primary school in Jere LGA to an alternative site. The Sub-Sector also negotiated the stay of eviction for 46HH residing in Jafra camp, MMC.

The Mine Action Sub-Sector coordinated by UNMAS, conducted Risk Education activities for 14,154 beneficiaries (4,192 girls, 4,256 boys, 3,481 women and 2,225 men). 95% of the beneficiaries targeted are in Bama, Jere, Gwoza, Konduga, Magumeri, MMC, Mongunu and Ngala LGAs, 4 per cent in Adamawa and 1 per cent in Yobe States.

Way forward: The Protection Sector plans to:

- Continue to participate in the implementation of the 90 Day Plan in MMC, Jere and Monguno.
- Follow-up closely on the installation of **lighting around the Stadium** structure. The Sector will also closely with the AAP/CE Working Group and other Sectors in the identification of and support to **community leadership structures in Stadium** camp.
- Participate in the rain season **preparedness planning** in March.
- Remain abreast of **developments in RANN** where between 30,000 and 40,000 persons are reported to have returned from Cameroon and contribute to discussions on possible humanitarian access, needs assessment and response.
- Enhance field presence to reinforce problem-solving and decision making at LGA levels. To this end, the Sector will regularly participate in the Inter-Sector Working Group (ISWG) missions.
- Map LGA-level protection coordination meetings to align with the Protection Sector Working Group meetings in Maiduguri to enhance communication and feedback.
- Maintain protection monitoring and referral activities in TVC and contribute to efforts inter-sectorial efforts to identify upgradable facilities to mitigate the effects of continued overcrowding, which is likely to worsen in the rain season.
- Engage in capacity development activities; the Sector's annual training calendar will be finalized in March. A 2-day training of Sector members will take place in beginning of April.

The HLP Sub-sector will organize **HLP mainstreaming training** in collaboration with the Food Security and Livelihoods Sector, to enable humanitarian actors implementing response and recovery projects to identify and address HLP issues.

The challenges faced by the **Mine Action Sub-Working Group** is the capacity and accessibility to respond to several accidents and explosive remnants of war contamination reported mainly by IDPs who fled the Kukawa LGA.



Child Protection

Achievements: In February, child protection partners reached 40,261 children (19,441 girls and 20,820 boys) and 19,796 caregivers (11,256 women and 8,540 men) with child protection interventions; this represents 4 per cent of the target for 2019 under the 2019-2021 Humanitarian Response Strategy. A total of 37,689 children and caregivers (15,982 girls, 17,354 boys, 1,538 women and 2,815 men) benefited from provision of psychosocial support.

A total of 444 unaccompanied and separated children and children with other protection risks (142 girls and 302 boys) received integrated case management services; of these, 22 children (9 girls and 13 boys) were reunified with the caregivers and 56 children (35 girls and 21 boys) were placed in alternative care and received follow-up visits. 264 children (55 girls and 209 boys) associated with armed groups benefitted from reintegration services.) A total of 9,752 children and caregivers (1,983 girls, 2,063 boys, 3,481 women and 2,225 men) were educated on mine risks.

The Sub-Sector trained 18 IOM DTM enumerators on basic child protection concepts and terminology; this was aimed improving the quality of information collected on child protection needs through the Displacement Tracking Matrix. In collaboration with the GBV Sub-Sector, 30 GBV case workers (26F, 4M) and 12 child protection case workers (9F, 3M) were trained on caring for child survivors. The CP Sub-Sector coordinated the response for the new arrivals under the 90-days emergency response plan in MMC, Jere and Monguno LGAs; the main challenge faced is limited availability of child protection services in Monguno due to funding constraints for child protection partners.

Way forward: The Child Protection Sub-Sector will continue to advocate for additional funding of 0.5M to ensure continuity in child protection in interventions for new arrivals in MMC, Jere and Monguno LGAs in Borno state.



Gender-based Violence

Achievements: Child survivors of Gender Based Violence (GBV) especially sexual violence require specialized support, techniques and treatment appropriate for their age, sex, culture and context especially keeping in mind the need to protect their physical and psychological well-being in the short and long term. The Gender Based Violence and Child Protection sub sectors trained 30 GBV case workers and 12 CP case workers on Caring for Child and Adolescent Survivors of violence. This training started a critical conversation on how the sub sectors will coordinate appropriate response to the needs of survivors, especially in the incidents where the child/adolescent survivor also has multiple needs. The GBV technical working group is currently developing basic guidelines for collaboration and information sharing to support the frontline staff.

To support ethical GBV incident data collection, storage and dissemination, 16 core GBV staff received training in GBV Information Management Systems (GBVIMS) basic tools, 38 GBV staff from two partner organisations received training in Primero - the advanced GBVIMS tool to be implemented 8 LGAs (Kukawa, Gwoza, Mafa, Bama, Monguno Ngala, Gwoza, and Dikwa in Borno state. The training focused on primero software, mobile data collection, data protection, data mapping, data collection tools and other Case Management tools. GBV case management training was also provided to 16 field staff of one partner aimed at building the capacity of caseworkers in responding to survivors of GBV and providing survivors with quality GBV response services. The GBV SS conducted an assessment to establish dignity and hygiene needs for women and girls of reproductive age. Specifically; the assessment set out to understand community expectations and considerations for the dignity of women and girls; the available and accessible basic hygiene products, to understand the needs, concerns, and perspectives so as to improve responses to better meet the needs of women and girls of reproductive age. Focused Group Discussions (FGDs) were conducted with a total of 82 participants in two camps targeting adolescent girls, adult women, men and boys. The findings from this assessment will inform the GBV SS response by facilitating a standardized but context-specific and sustainable approach to the development and distribution of dignity kits

Way forward: The GBV sub- sector plans to:

- Develop Dignity Kits Guidance Note that clarifies the terms of common standards will apply to all partners involved in dignity kits programming
- Conduct training for PSEA Focal Persons on Inter Agency Community Based Complaints Mechanism (CBCM) for SEA and facilitate the development of the HCT's PSEA Action Plan 2019.
- Conduct training for CCCM staff in GBV mainstreaming and risk mitigation


