	<p>Inter-Agency coordination Associate Ms. Samira Smairat provided a quick update on the on the status of JRP,3RP and the Financial tracking system (FTS). The briefing on JRP was provided based on MOPIC presentations delivered in the July,2019 JRP workshop. The main update points are:</p> <ul style="list-style-type: none">• Joint Comprehensive Vulnerability Assessment• Pillars Structure• Sectors restructuring• Gradual inclusion of local councils• Discussion on sectors merging at high level <p>UNICEF made a comments on the delays reported from MOPIC side regarding project approval process and requested the UNHCR to continue advocating to improve and minimize project approval process at high level. ISWG confirmed that the FTS reporting is going well and partners are reporting regularly.</p>

The situation is better in Mafraq were we have one CHV for 1,423 refugees. In Amman one CHV for 4,127 refugees. IOM will be updating the sheet as they have new community health project.</p> <ul style="list-style-type: none"> - Regarding the survey that Medair and IRC are conducting to measure the effect of the new MoH policy, the data collection was finished in September and the data analysis will take place in October. Report will be shared with the HSWG.
Mental Health	<p>IMC provided an updated on the study the conducted in Feb-March,2019. The survey revealed that the need for Mental help support is getting decreased.</p> <p>UNICEF will conduct two training for all staff engaged in Nutrition. TOT training on Infant and youth child feeding and (IYCF). The trainers is currently hosted by UNICEF partner IMC</p>

Health Agencies update	
JPS's	<p>JPS has ongoing project activities in support of secondary and tertiary referrals for Syrian refugee in camp settings for provision of Secondary and tertiary health care services including EOC with access to NNC and child care, lifesaving and medical care for the critically ill.</p> <p>A total of 44 cases were supported in September from the camps, including 21 cases received from Zaatari RC , and 13 case received from Azraq RC of which 16 cases were CS, 6 NVD, 7 EOC, 4 NNC, 5 DC and 6 LES.</p> <p>JPS has also ongoing activities in support of secondary and tertiary services for refugees in host communities in September, 2019, as follows:</p>

	-A total of 1195 cases were supported in September. Of the supported cases were 658 Syrian, and 537 cases were from other nationalities; Sudanese (246), Iraqis (159), Yemenis (77) and Somalis (24). Of which, 415 cases were provided with Investigation/Consultation services, and 780 cases were provided with treatment/Intervention services.
