



## 1. FTS 2<sup>nd</sup> Quarter Report

UNHCR Information Management Officer briefed on the current funding status and how to obtain the data from the FTS website (<http://scs.raisunhcr.org/FTS/tst.aspx>).

The importance of financial focal point from each Sector to report to FTS was again emphasized.

It was again explained and emphasized that the funds received in 2017 for 2018 as a part of multi-year appeal, which was newly introduced in 2017, have been included in the reporting on funds received in 2018 for this year's project.

## 2. JRP Project Approval Concern

Currently, the JRP calendar for 2018 has not been issued as the JRP Secretariat is not functioning due to underfunding. Due to the current situation with the absence of JRP Secretariat, project approval is being delayed. UNFPA updated that the projects of the Protection Sector will not likely be approved until the end of the year and the JRP for next year resumes properly. However, the point was raised that there should not be any issues with 2018 projects because they should have already all been approved before. JIF issued a survey report on project approval, which is currently being reviewed also by donors for additional comments and support.

Discussion is ongoing amongst the international community, and an ad-hoc HPF will be held on 6 August to discuss the issues related to the JRP Secretariat and the JRP process for 2018.

## 3. Humanitarian Development Nexus

ISWG consultation to reinforce the resilience pillar of the 3RP was reminded and how sectors were requested to provide inputs based on the sectoral consultations on how the Jordanian Government's national development plan could be adopted into the current resilience pillar of the 3RP. Recommendation was made before to adopt the JRP to include the national development plan by analyzing what is not covered in the 3RP.

So far, we have received update from the Health Sector, which still requires revision, and updates from other Sectors are required. Sector inputs will be utilized to strengthen the JRP with its transition to a more development focused approaches while maintaining the humanitarian response to the refugee crisis.

A correspondence will be sent to remind the sectors and to gather inputs in August and September.

## 4. ISWG Work Plan

Sectors are reminded to provide an update on the work plan as it requires follow-up and update on the current status. The deadline to submit the feedback is extended until the 16 August.

Sectors also requested for information on which SGFP attended the SGFPN to know the progress in order to be able to request the SGFPs to present an update in the sector meetings.

## 5. AOB

3RP Mid-Year Report – UNHCR Regional Office requested 250 words from each Sector, which should include the consequences of underfunding with detail figures on how many Syrians and Jordanians would be affected.

UNHCR VAF Coordinator presented on the Vulnerability Assessment Framework, which is a coordinated framework to assess vulnerabilities of refugees in all Sectors, and the result of the population survey conducted in 2017. Sectors are asked to request as necessary for the VAF findings and how it can be utilized to be presented in their Sector meetings.
