

# **Bosnia and Herzegovina**

an 11% increase compared to October 2020. As with the previous three months, there were no UASC amongst irregular 12 first-instance decisions\* were issued in arrivals in October. The total number of arrivals in 2021 is 14,511, which is on par with 2020 figures (14,557), while 83,924 arrivals have been recorded since the start of the mixed movement in January 2018.

1,133 persons (93%) arriving in October expressed an intention to seek asylum with the Service for Foreigners' Affairs (SFA).

**1,217** migrants and asylum-seekers arrived **6** Refugee Status Determination (RSD) irregularly in BiH in October, representing interviews were conducted in October, five a 22% decrease over September 2021, but of them in UNHCR's Information Centre and one in Immigration Centre.

> October: 2 granting derivative refugee status, 5 subsidiary protection and 5 negative decisions. 18 asylum claims were suspended, and one negative decision was issued on appeal.

> 34 asylum claims were registered with the Sector for Asylum in October, all were conducted in UNHCR's Information Centre in Sarajevo

433 days - the length of the asylum procedure for the first-instance decisions\*\* issued in October.

248 days - the average amount of time persons waited to register\*\*\* an asylum claim for those claims registered in October.


2,978 asylum-seekers and migrants were accommodated in reception facilities at the end of October, while 800-1,100 persons are estimated to be squatting outside of formal accommodation, mostly in Una-Sana Canton.

59% of asylum claim registrations scheduled in UNHCR's Info Centre were conducted

#### **KEY INDICATORS AS OF END OF OCTOBER 2021**

- 180 registered asylum-seekers pending processing and decision, of which 50% (90 people) involved persons in families
- **91** people awaiting registration of their asylum claim with the assistance of UNHCR/Vaša Prava BiH
- 54 refugees in the country, of which 7 are from outside of the former Yugoslavia
- 67 persons under subsidiary protection in BiH
- 132 stateless persons and persons at risk of statelessness being assisted by UNHCR and partners


#### ASYLUM CLAIMS PENDING PROCESSING AND FINAL DECISION AT THE END OF OCTOBER - TOTAL: 180






#### **REGISTRATION AND ASYLUM PROCESSING IN 2021**



#### **ACCESS TO THE ASYLUM PROCEDURE**


In October, the Sector for Asylum conducted the highest number of registrations of any month in 2021, registering 34 people (compared with single-digit registrations in the previous two months). Significantly, not only were more people registered than in previous months, but the percentage of scheduled registrations that were conducted was also the highest compared to any previous month in 2021, with 59% of scheduled appointments being filled (in August just 8% of scheduled registrations were conducted). This increase in the number and percentage of registrations conducted demonstrates an improvement in the Sector for Asylum's ability to differentiate between genuine asylum-seekers and migrants in transit in a context where all irregular arrivals are issued an attestation of expressed intention to apply for asylum, regardless of actual intention.

#### **REGISTRATIONS IN UNHCR INFO CENTRE IN 2021**



In addition, there was a significant increase in the number of persons registered from Una-Sana Canton, with 12 out of 34 persons registered (12/19 cases) involving persons residing in Una-Sana Canton. Notably, one individual from TRC Miral was registered, representing the first registration from the camp since its opening in October 2018, while 5 registrations were conducted for residents of TRC Borići, the first from the centre since October 2019. Prior to October, only 2 persons had been registered from Una-Sana Canton in 2021, and none who were residing in any of the TRCs. UNHCR has been advocating consistently for the Sector for Asylum to ensure access to asylum for all those interested in applying and is encouraged by these latest developments. However, access to asylum remains problematic in BiH, particularly for residents of TRC Blažuj, where no individuals have been invited for registration since the camp opened in December 2019.


# REGISTRATIONS IN 2021: Top 5 Country of Origin



# 2021 ASYLUM PROCESS INDICATORS MAP




Average processing time\*\* for first instance decisions issued in 2021 as of the end of October

#### ASSISTANCE PROVIDED BY UNHCR IN OCTOBER

- 1,862 legal aid and information assistances provided by UNHCR and Vaša Prava BiH with support from the European Union (IcSP and IPA SM III projects) and AMIF.
- 442 other protection assistances provided by UNHCR/BHWI to asylum-seekers (informal education, occupational/recreational activities) with the support from the European Union (IcSP I and IcSP II projects) and AMIF.

739 core protection assistances provided by UNHCR/BHWI to asylum-seekers (psychosocial assistance, protection assistance for UASC, GBV activities) with the support from the European Union (IcSP I and IcSP II projects) and AMIF.

Since 1 June 2020, UNHCR senior protection liaison assistants have provided information on access to asylum in BiH to 3,466 persons.
